& conclude this my last will & Testament revoking all others  
I do commend my spirit to God who gave it, & my body to  
earth in a decent Christian manner.

I will that all my lawful debts be punctually paid out of my  
estate so as to leave a sufficient sum of my friend James Jamison  
as shall be necessary to defray the pro-rata of such parts of my  
property as may not herein after be mentioned by my executors  
I will so much money to be raised out of my estate to be ap-  
propriated to the use of my friend James Jamison as will be  
necessary to defray the expenses of procuring a Deed for the Mills  
& Lands thereto attached for which I stand bound'd & for which  
Mills & Lands I have received couple "alot" & that he shall pos-  
sure said Deed in his own name as the Land has not been  
run, I desire it to begin at a Cherry tree near the east corner  
of the old ... & run the south & west according to entry there of  
and that in the said James Jamison be hereby bound in his own  
name & make it Robert Sherwood and Whitfield his wife's  
sole good & sufficient Deeds of conveyance for the several  
tracts to them belonging out of the original as soon after he  
shall procure it as they or either of them shall desire the  
sum in sum is my Executrix as they or either of them stand  
bound'd for me -

I give this Deed to my beloved wife Nancy my intentions  
now & all the land she may have use for in raising the fa-  
mily during her life or widowhood after either of which they  
shall be in the power of my executors to use to the best adven-  
tage of my children equally till they respectively come to  
the age of twenty one years, They my sons who share my lands  
I likewise give & bequeath to my beloved wife all my lands  
during my life or widowhood and after ward to the use of my

I now give my spirit to God who gave it, & my body to  
buried in a decent Christian manner.

2<sup>nd</sup> I will that all my lawful debts be punctually paid out of my  
estate so as apportioned to the uses of my friend James Jamison  
as shall be necessary to defray the procast of such parts of my  
property as may not herein after be mentioned by my executors  
I will so much money to be raised out of my estate to be ap-  
plied to the use of my friend James Jamison as will be  
necessary to defray the expences of procuring a Due for the mills  
Islands thereto attached for which I stand bound & for which  
mills Islands I have received ample value & shall he shall pro-  
duce said Due in his own name as the land has not been  
run, I desire it to begin at a Cherry tree near the east corner  
of the old Barn & run the due & bound according to entry thereof  
and that in the said James Jamison be hereby bound in his own  
name or make it Robert Sharswood and Whitehill his executors  
to pay good & sufficient deeds of conveyance for the several  
tracts to them belonging out of the original possession after he  
shall prove it as they or either of them shall advance the  
sum or sums so my executors as they or either of them stand  
bound for, to me -

3<sup>rd</sup> I give & bequeath to my beloved wife Nancy my Mansions  
house & all the land she may have use for in raising the fa-  
mily during her life or widowhood either of which they  
shall be in the power of my executors to use to the best advan-  
tage of my children equally till they respectively come to  
the age of twenty one excepting my sons who share my lands  
& either man give & bequeath to my beloved wife all my Estate  
during her life or widowhood and after next to the use of my  
executors equally also one house of her choosing her last dis-  
position to her sons & her minister with all her clothing for  
4<sup>th</sup> I give & bequeath to my two sons James & William the whole  
of the sum in which I have about these hands in case to be equally  
divided between them taking quality & quantity into con-

consideration and the mansion house to belong to William  
I also give & bequeath to my son James one horse & saddle of his  
choice after my wife's decease.

6th I will & bequeath to my three daughters Jean, Esther and Sally  
together with the infant not yet born, an equal share of  
my estate not otherwise disposed of in the above Will and  
Testament. Lastly I do hereby constitute & appoint  
my Brother Samuel Brown and my wife Attorney Executrix  
of this my last Will & Testament. In testimony whereof

to remembrance the mortality of my body & that it is mortal  
for all the Human family come to die. I hereby command  
my soul to almighty God who gave it me, and my Body  
to the Earth from whence it came to be buried at the dis  
cretion of my executors hereafter appointed; and as touching  
my worldly property which it hath pleased God to bless  
me with in this life I dispose of in the following manner by  
them. I order & it is my Will that all my just debts be first paid  
them. I give & bequeath to my son Walter Bell all the property both real  
& personal which I have given & may give him heretofore, that he  
hath now in possession. I also order & it is my will that my said  
Walter keep my negro girl who is now has now in possession  
about seven or eight years old with all the above mentioned  
property to be his & his Heirs forever. I give said girl named  
Linda to my said son Walter as a compensation for a part  
of my estate come to me by his mother my first wife
