Mare & the one half of the remainder of my Stock of cattle
& Sheep & one feather bed & furniture & one half of my
Kitchen furniture & all my plantation tools that
at this time possess & no further divide of my Estate
Item I leave to my daughter Dorcas Swann the
plantation whereon I now live with all the appur-
tenances thereto belonging one feather bed & furniture
& all my household & dresser furniture & the one
half of my Kitchen furniture & the remainder of
my Stock of Cattle & Sheep, and it is my will & desire
that my son Joseph Swann pays my son William Swann the
five dollars left to him in this my will, & do hereby re-
-minish & appoint my two sons John Swann & Joseph Swann
Executors of this my last Will & Testament, and I do hereby revoke
& disannul all other Wills by me at any time made either by
word or writing & pronounce this & this only to be my last Will &
Testament, I do hereby seal up the same to sit on my hand & seal
