In the name of God Amen, This day of January
in the year of our Lord 1819 I Samuel Wilson junr of the
County of Mecklenburg in the State of N^o Carolina, being
in perfect health & disposed to travel to a distant place
knowing that it is appointed for all men to die -
Do make this my last will & Testament in the following
manner - First of recommending my soul to God, my body
to the Earth to be buried, and as touching my worldly
estate I give & devise as follows: It is my will & desire
that my just debts be paid, and after the payment
of my debts, I give & bequeath to my daughter Dore
the one half of my estate to her or uses I give &
bequeath to my sisters son David Waugh and my

Brother Winslow son Hugh I reserve the remainder of my Estate to be equally divided between them excepting five Shillings to each of my two brothers Benjamin and Lawson. I give & bequeath to my brother Winslow all my Belonging appurten. It is my will & I declare that no person may distract my father's fee and Debts due to me during his lifetime. Lastly I names, Nominate, Constitute & appoint my brother Winslow Executor of this my last Will & Testament, having rescind all other Wills by me heretofore made either before or heretofore. Ratifying & confirming this & no other to be my last Will & Testament signed before pronounced & declared by Samuel Wilson as his last will & testament in presence of
