of them in the following manner Agreed to this my last Will &
Testament. I bequeath my Soul to God who gave it
& my body to the Earth from whence it came to be decently buried
at the discretion of my Executors which I expect to be provided
of the whole of my Estate. 2d It is my Will & desire that all
my Just debts should be paid out of my Estate as soon as my Estate
can be settled. 3d It is my Will & desire that all my lands lying
on the South waters of Debatory Creek, Fairfield district South
Carolina, near to Rocky Mount, one tract containing five
hundred acres adjoining land of Richard Gater & Mr Poll
carpenter, another tract containing one hundred & fifty acres
adjoining Mr Poll on the other side opposite the other tract
also one small tract of fifty acres lying long side the second
tract shall be sold & out of the neat monies arising therefrom
my Just debts be all paid also six hundred sterling year to be
paid to my respected son by the widows Wallace until he shall
be 12 years of age — And further it is my desire if any remain
after he yet undisposed of it be sent to be kept for the benefit of my
daughter now living with Esq Mason within seven miles of

Holmes Town N^c Carolina the principal to be paid to her with
Simple Interest when she arrives at the age of Eighteen Years -
And I do by these presents make, constitute & appoint my true
& trusty friend John Lawson to be my lawful Executor to this my
last Will & Testament, hereby revoking all former Wills & Testaments
in Testimony whereof I have this day hereunto set my hand &
affixed my seal This 2^d day of November in the Year of our Lord 1808

a low condition but of perfect mind & memory calling to mind the
mortality of my body & knowing it is appointed for all men once
to die, do make & declare this my last Will & Testament in the following
manner & form, I Give & recommend my soul into the hands of God
that gave it, And my body to the earth to be buried in a Christian
like & decent manner at the discretion of my Executors nothing
doubting but at the general Resurrection I shall receive the same
again by the mighty power of God. And as touching such worldly
whereunto it hath pleased God to bless me with in this life I give
devise & dispose of the same in the following manner & form -
Impressed. It is my Will & I do Order in the first place that all my last
debts & funeral Charges be paid & satisfied. Item, It is my Will & I do

Implement & all my House hold furniture with all my stock of
cattle & Hogs, also as much money as will make my dwelling house
comfortable to live in, for the use of my dear, but now wife, Ann that
now live during her life & widowhood, I also give & bequeath unto her my
well beated & one hundred dollars to dispose of as she pleases, Item I
give & bequeath unto my married daughter Mary wife to John B.
a Negro Girl called Betty & Horse & Saddle with all the furniture
I put into her hand after her marriage to be hers, her share in the
