testament. Impioris I bequeath my soul to God who gave it
& my body to the Earth from whence it came to be decently interred
at the discretion of my executors which expenses to be paid out
of the whole of my Estate. It is my will & desire that all
my just debts should be paid out of my Estate as soon as my Estate
can be settled. It is my will & desire that all my land lying
on the South waters of Debatory Creek, fairfield district land
Carolina, near to Dickey's Mill, one tract containing five
hundred acres belonging land of Richard Gates & Mr. Poll
respecter brother tract containing one hundred fifty acres
adjoining Mr. Poll on the other side opposite the other tract
also one small tract of fifty acres lying long side the second
tract shall be sold & out of the net monies arising therefrom
my just debts be all paid also five pounds sterling yearly be
paid to my reported son by the widow Wallace until he shall
be 12 years of age - And further it is my desire if any remain
after his just maintenance of it be paid to interest for the benefit of my
daughter now living with Egg Mason with in seven miles of

Halifax Town N^o Carolina the principal to be paid to her with
Simple Interest when she arrives at the age of eighteen years -
And I do my three, present make, constitute & appoint my true
& trusty friend John Pearson to be my lawful Executor to this my
last Will & Testament, hereby revoking all former Wills & Testaments
so testimony whereof I have this day hereunto set my hand &
affixed my seal this 2^d day of November in the year of our Lord 1808

Age of 61 belonging County & State of Carolina, being sick & in
a low condition but of perfect mind & memory calling to mind the
mortality of my body knowing it is appointed for all men once
to die, do make & relate in this my last Will & Testament in the following
manner & form, I give & recommend my soul into the hands of God
that gave it, and my body to the earth to be buried in a Christian
like & decent manner at the discretion of my executors nothing
doubting but at the general Resurrection I shall receive the same
again by the mighty power of God. And as touching such worldly goods
wherewith it hath pleased God to dress me both in this life I give
dear & dearest of the same in the following manner & form -
Imprimis. It is my will & I do order in the first place that all my just
debts & funeral charges be paid & satisfied. Item. It is my will & I do
order that the Land I now live on with two horses & my farming
implements & all my house hold furniture with all my stock of
cattle & hogs, also as much money as will make my dwelling house
comfortable to live in the use of my family, be left unto Martha
in use during her life time. I also give & bequeath unto her my
wife to watch & one hundred dollars to dispose of in the pleasure, Item I
give & bequeath unto my married daughter Mary wife to John B.
Beale a grey gelded horse & saddle with all the furniture
I put into his hand after her marriage to be hers, her share in such
