In the Name of God our Saviour: I Thomas Kennedy of the County of
Charleston and State of N^o. Carolina being in a condition of health
but of dimid mind & memory this 10th day of March in the year of
our Lord 1826. make publish and declare this my last will &
testament in manner & form following viz.

I give & bequeath unto my wife Rebecca Kennedy one Negro
man named Andrew from me as woman named free & full
youngest child named Harry to be her slave, I also give my
wife Rebecca the one half of the tract of Land I now live on
for her to maintain my son David Kennedy & his wife David
Kennedy lives longer than my wife Rebecca said Negro & land
shall be maintained with David during his natural life &
at the death of said Rebecca & David said land to be the property of my
heirs & Francis Kennedy shall also give my wife Rebecca two horses
her choice of my Stock.

I give & bequeath to my daughter Eliza Kennedy one Negro girl
named Lucy from me as boy named Abby, one horse & saddle
with a lead & bridle, one book & pen case and one cow.

I give & bequeath unto my son Thomas Kennedy one Negro man
named Nathan, and one horse named Kennedy his saddle and bridle
one bed & furniture and one cow.

I give & bequeath unto my son Francis Kennedy one half of the
plantation I now live on leaving the other & improvements to
eldest brother for the use of my wife Rebecca & son David & his wife
Dicks with one book & furniture and one cow.

I give & bequeath unto my Daughter Abigail Kennedy one Negro
girl named Harris & one horse saddle & bridle one bed & furniture
and one cow.

I give & bequeath unto my son Thomas Kennedy one Negro boy
named Samuels, one Negro boy named Jacob & one hundred dollars
in money & one horse saddle & bridle one bed & furniture and one
cow I give & bequeath unto my wife Rebecca Kennedy the remainder
of my household & kitchen furniture, farming utensils and the
remainder of my Stock of heth, Hogs & Sheep to be her property
and I do my then present & future disannul & make void all former
wills or Testaments by me made & given.

First answer the questions & form following Viz -

I give & bequeath unto my wife Rebecca Kennedy one half
in and named Andrew & one half Woman named Sally & Sally
youngest child named Harry to be hers forever, I also give my
wife Rebecca the one half of the tract of Land I now live on
for her to have & naming my son David Kennedy & his said son David
Kennedy lives longer than my wife Rebecca said my son David
will to maintain & look David during his natural life &
at the death of said Rebecca & David said land to be the property of my
third son Francis Kennedy & also give my wife Rebecca two horses
her choice of my Stock.

I have & bring you with 1000 of daughter Eleanor & Kennedy our Negro girl named Lucy, born Aug 10 being named today. Your house regards much with a good & kindie, one bush & four others and one low -

I give & bequeath unto my son Francis Kennedy on behalf of the
plantation I now live on leaving the house & improvements ex-
clusively for the use of my wife Rebecca & son David & his wife
Dicks wife can be & have and use how —

yea named Harriet Conklin Soddy & Briddle on her land
providence and grace.

I year & he jessells unto my son Thomas Kennedy on negro boy
named Samuels, & one negro boy named Jacob Wilson bounded & sold
in money & cattle & saddle & bridles & harness & with any
obliges I give & pay you to my wife Rebecca Kennedy the remainder
of my household & kitchen furniture, farming utensils & the
remainder of my stock of cattle, hogs & sheep to be held for me
, And I do by these presents release, disannul & make void all former
will or testament by me made - and I do now appoint my wife Rebecca
Kennedy & my son by said Sarah Wilson my only legal Administrator
hereunder this my last will & Testament, the last day whereof I have been
and let me be not afraid before the day & year above written to sell
this in payment of her legacies ^{and} debts remaining ^{and} I am & remain ^{ever} Yours
