" In the name of God Amen. I Thomas Tanner of the State of North
Carolina in Rockingham County. A being throu' the abundant
mercy & goodness of God, though weak in body yet of sound &
perfect understanding & memory, Do constitute this my last
Will & Testament as follows: I give & bequeath to my beloved
wife Rachel Tanner her choice of the bed & furniture & all her
cloathing & linole of every kind, with all kitchen furniture only
what I well here after mention, Also her mare & colt & Bridle
two cows &c. Also her choice ^{inconsidering my wife will also own} of many of the Hogs as well as
sheep & lambs, also 200 sheep ^{by giving} I give & bequeath to my
daughter Elizabeth Sibley for my wife I assign the sum of ^{one} hundred
and ten dollars & my other choice I give & bequeath to my
wife Rachel Tanner all the land & premises wherein I now live
during her life & as many of the farming utensils as will be thought
necessary for her to keep and at her decease all land &
moveable property to be so legallly divided among my children
viz Elizabeth Sibley, Jane Tanner, Rebecca Raw, & my
daughter Jenny Tanner, And my son John Tanner nor his wife shall
have him on my land to live, my wife is living, also I desire
that none of my estate or other money I may possess to give away
to any while my wife is living, also I give & bequeath to my
daughter Jenny her bed & furniture & all her cloathing belonging
to her of every kind, also her mare & Bridle, Also Seventy
dollars paid in the hands of my executors to her heirs ⁱⁿ the
sum of

15 Daugt^r Jenny a tract when she stands in need of it, also I give & bequeath
m^r, daughter Jenny one Cow & Calf one two year old Heifer her choice
aft^r her mother has her choice, also I give & bequeath my daughter
Jenny her wheel & Cards, with the second largest pot & part of the
dishes furniture, together with her Maintenance of the plantation
as long as her mother liveth, or as long as she lives single, Also
I give & bequeath to my daughter Jenny the Loom & all belonging
thereto, Also the balance of the property that is not mentioned
in my will to be sold & the money arising therefrom to remain
in the hands of my Executors for the use of my wife Rachel if she
lives in need of it, if not to remain in the hands of my Exec^{rs}
until her death then to be divided equal amongst my
children as is hereof mentioned, Also the two horses of mine
that is strayed off if found I give & bequeath the large Horse
Oregon to my daughter Jenny & the Money that is left her in my
will to purchase a Horse to remain in the hands of the executors
until my wifes death to be divided amongst my children
as before mentioned & the other small horse if found to be
sold along with the rest of the prop^{ty}. Also I give & bequeath
to my daughter Jenny two Ewe sheep -
