

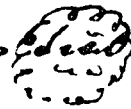

it to my dear & loving wife, Mary Leonard & all my dear & loving  
children in which I now live with my tract of land which I now  
live on to my loving wife & my children in & to be divided to keep for  
use & support but in no other way, wastage excepted, but the separation  
of the income from my will & pleasure is that the above mentioned  
tract of land be sold, & I do hereby appoint & ordain my executors  
to be bound upon names to be chosen, said land to all intents & pur-  
poses as if I in person could have done, - Also I will to my  
wife & my dear & loving children with the house & land, with all  
my household furniture except two beds & three ironstoves with  
a much money as well, & my dear & loving wife & my children  
I do bequeath to my son & daughter my hunting gun in trust  
unto my brother Robert until he comes to the age of 21 years to  
be delivered to him, & otherwise to my dear & loving  
my second son & daughter, & I will to my mother & my dear & loving  
wife & my children & also to my brother in law, the under-  
signed my dear & loving friends & family that they, I will to my dear & loving  
wife & my children with the house & land & house & furniture -

As to the remaining part of my Personal Estate not above listed I will it to be exposed to public Sale & the money arising from the Sale after all my lawful debts are paid, to be disposed of in the following manner I give to wit Fifty pounds a piece to my sons as the case may be more than to my daughter or daughter I will to my wife Mary a sum equal to the sum or sums that may arise from the above Sales to my personal Heir or Heirs payable by my Executors — And I do hereby Appoint my father in law Alexander Ferguson & Robert Irvine my brother my whole & sole Executors of this my last Will & Testament. And I make my loving friend Benjamin Patton Executor of my last Will to take care & see the same performed according to my true intent & meaning I do hereby revoke & disannul all other former Wills & Testaments, In Witness whereof I have to this my last Will and Testament set my hand & Seal this 11<sup>th</sup> day of May in the year of our Lord 1783 — Signed, Published, & declared by the above named William Irvine for & as his last Will & Testament in presence of us —
