Last will and testament of David Barton and
in the name of God amen I David Barton of the City
of Helena in Phillips County and State of Arkansas being
in good health and of sound and disposing mind and
memory but knowing the frailties of human nature
that all must die and being desirous of disposing of
whatsoever worldly estate it has pleased God to give me
with as I think proper just and desirable do hereby make
publish this my last will and testament hereby making
all former wills by me at any time heretofore made
void I desire my immovable estate to be divided into three
that God who owns it trusting to his own Providence for
its final redemption and eternal satisfaction in Heaven
I give my body to be buried at the discretion
of my friends. I hope not in an expensive manner

Item 1st It is not my intention to leave any debts due from
me at the time of my death but should I be so it is my
will and desire that they shall be paid together with any funeral
expenses out of any funds my wife may see proper to apply
therein belonging to my Estate but as soon after my death
as may be convenient and proper for her to attend to such
matter

Item 2 I give and bequeath unto my Mother Wilson C. Barton
and to my Sister Susan J. Barton the Colgate's Communion
each the sum of one dollar to be paid to them if living if not
to their Children if any living by my wife out of any funds
belonging to my estate as soon after my death as may be
convenient and I give and bequeath unto the Children
of my Mother Richard D. Barton deceased to wit Mary Hattie
Emma Davis and Richard Barton the sum of one dollar
each to be paid to them in like manner by my wife

Item 3 I give and bequeath unto my Sister Susan J.
Barton for and during the term of her natural life the
use of all and whatever in land and property I have or
may have in the State of my Mother Susan Barton late
of Montgomery County North Carolina decess the same to
be put and kept at interest by her and she to have and
use the interest arising therefrom for her own use and

and benefit as she may see proper and she is not to be required to give bond or security to any one for said property or money for the return or safe keeping or management of the same

Item 6 After the death of my sister Susan A. Burton it is my will and desire that my said interest and property in my fathers estate shall be divided into three equal parts One of which I give and bequeath unto my Brother Wilson S. Burton of living if not to his Children And I give and bequeath unto my sister Elizabeth H. Rowland if living if not theirs to her Children and One I give and bequeath unto the Children of my Brother Richard W. Burton dead

Item 7 I give and bequeath unto my beloved wife Emily S. Burton absolutely and in fee simple all of the balance and remainder of my Estate and property which I may have and leave on earth at the time of my death whether the same may be real personal mixed Choses in action or of any other Character nature or kind whatever the same and all right and title thereto and interest therein is hereby made or intended to be made to vest in her absolutely and in fee simple on my death should she out live me subject only to the payment of my just debts and the legacies herein above set forth with full power and authority to collect all debts that may be owing to me by all lands or realty I may leave by deed absolute as she may see proper and convenient to use and dispose of said property or the proceeds arising from the sale thereof and any and every I have in hand at my death as she may see proper and desire whether it be to dispose of it by will or otherwise, it being my intention hereby to give her the same right and title to the said property that I may have at the time of my death having full faith and confidence in her and believing that she will use and dispose justly and proper

Item 8 It is my will and desire and hereby direct that after my death this my last will and testament shall be publicly proven probated and spread upon the Records of the County in which I may have any estate then at the time of my death and that my Estate remain entirely under the control of my wife

and that no titles testamentary or of Administration shall ever be granted or issued upon my estate nor shall my wife Emily S. Burton be required to answer or account to any Court or to any person or persons whatsoever for my estate or any part thereof except so much as may be needed to pay my debts General Expenses and the legacies as above set forth and bequeathed nor shall my said wife Emily S. Burton be required to give any bond or security for the management of my Estate in any shape or form whatever in testimony whereof I hereunto set my hand and seal and publish and declare this to be my last will and testament in the presence of the Witnesses named herein on this the 16th day of October A. D. 1875
