

Duncan Blues Will

- To all people to whom these presents shall come I the said Duncan Blues of the County of Moore and State of North Carolina for and in consideration of the love and good will and affection he had Thine and do bear to write my loving wife Margaret -
- 1st Give and bequeath unto my dear beloved wife her Maintenance out of my Estate during her life time -
- 2^d Also Give and bequeath unto my son John Blues of the same County and State aforesaid the sum of three Hundred and fifty Spanish Milled Dollars to be paid and laid out of my Estate after my death, for him the said John his heirs Executors or Administrators or assigns -
- 3^d Also Give and bequeath unto my son Patrick Blues of the same County and State aforesaid the following tracts of Land, two Hundred Acres situated on the South Side of lower Little River known by the Lindens land - Also an other tract of twenty Acres on the ridge path that leads from Water Mill to Daniels Mill at the pond and other tract of forty Acres on the North side of Curriers Branch near the Mouth of said Branch including the pond South of the said Branch all lying and being in the County of Moore the said tracts of Land to be enjoyed and enjoyed by him the said Patrick his heirs Executors or Administrators forever against all lawfull claims what soever -
- 4th Also Give and bequeath unto my son Patrick Blues of the same County and State aforesaid the following tracts of Land, fifty Acres on the South Side Chadocks Creek where Snow live with all its Improvements - Also ten Acres joining the said tract including the old peach Orchard, Also an other tract of two Hundred Acres on both sides of Chadocks Creek including Tappans Old field, Also an other tract of twenty Acres on both sides of Chadocks Creek including the mouth of said Creek, Also another tract twenty six Acres on the ridge path near the head of the horse pen Branch, the said tracts of Land to be paid and enjoyed by him the said Patrick Blues his heirs Executors or Administrators for ever against all lawfull claims what soever -
- 5th Also Give and bequeath unto my son Patrick Blues and Duncan Blues all my movable Effects, to wit, six Negroes Edmond, big Tom, Hugo, Harrah, Little Tom, and Lude, and all my horses cattle Hogs, and all my household furniture - the above movable property to be Equally Divided between the said Patrick Blues and Duncan Blues after my death, provided the said Patrick Blues & Duncan Blues pay when they the said sum of three Hundred and fifty Spanish Milled Dollars above written and bequeathed -
- 6th Also Give and grant unto my Daughter Sarah four Cows and calves or forty Dollars out of my Estate after my Death -
- 7th Also Give and bequeath to my Daughter Sarah four Cows and calves or forty Dollars out of my Estate after my Death -

Fourthly - Also Give and grant to my Daughter Effy four Cows and calves or forty Dollars out of my Estate after my Death -

Alexander McLeod's Will

In the Name of God Amen - I Alexander McLeod of Moore County and State of North Carolina being of Sound and perfect Mind and Memory (Praised be God) do this twenty first day of December in the year of our Lord one thousand eight hundred and fourteen Make and publish this my last will and Testament in Manner following that is to say, first Give and bequeath to my wife Nancy McLeod my Negro Girl named Nancy or Names, which Girl after her death is to belong to my Sons David and John, Likewise give and bequeath to my Wife during her lifetime the plantation between Slaves and my stock of Hogs, Sheep and Cattle, Plantation Mills, Household furniture of whatever kind to description, and whatever else appertaineth unto me except what with her hereafter mentioned, which Plantation Stock, Chattels, furniture &c after her death will belong to Sons David and John, Likewise give and bequeath to my wife the sum of one Hundred Dollars in Money - to my son Angus McLeod and bequeath a small Negro Girl named Sarah to my son Ben McLeod give and bequeath my Negro Woman named Ray and her son Jim and a little Girl named Chasing, and one Hundred and fifty Dollars in Money, and one half of my Land (excluding the above mentioned Plantation) which half is to consist of fifteen acres of the more fertile parts of my Land lying on the Little Sanifer little River and their Branches - To my Daughter Effy Give and bequeath a small Negro Girl named Rose, To my Daughter Mary Give and bequeath a small Negro Girl named Sarah To my son John Give and bequeath my Negro Woman named Lucy, and two small Negro Boys named Harry and Aaron, two Hundred Dollars in Money, and the remaining half of my Land, lying around my plantation and down Little River and its Branches, and thereby make and ordain my Son John Executor of this my last will and Testament, in witness whereof I the said Alexander McLeod have to this my last will and Testament set my hand and seal this 29th of August 1806
