Secondly I give and bequeath to my Daughter Mary Roy. Sarah McFarland and Jan Clark the tract of Land that I hold in all out going to be to be Equally divided among them -

Thirdly I give and bequeath to my son James R Clark all the Land I hold in Moore County together with all the farming Wincks, in the said James R Clark having the care of his Mother for life time -

Fourthly I give and bequeath to my Wife Christian Clark and my son James R Clark all the real Estate of Horse Wagon Cattle and Sheep and my Wagon and also a rifle gun -

And I hereby make and ordain my son James R Clark Executor to this my last Will and testament in testimony Whereof I the said Archibald Clark have to this my last Will and testament set my hand and seal the day and Year above written

In the Name of God Amen I James Kelly of the County of Moore and State of North Carolina being of sound Mind and Memory Calling to recollection the mortality of my body do publish and ordain the following as my last Will and testament. First I will give and bequeath to my Eldest Daughter Catherine Kelly one Cow and calf and a small piggy my Executors herein after named the other part or portion of my real or personal Estate. Second I will give and bequeath to my son Alexander Children one Cow to be delivered by my Executors to the Mother of said Children for their usual support. Third I will and desire my Executors to see all my real and Personal Estate

at such time and upon such Estate as to them may seem proper and after paying all my personal Expenses and Debt debts that the balance of the proceeds of said Estate together with all my other due one be divided by my Executors between my son Jacob Lin and Catherine Kelly Executor share and share alike but I request and desire my Executors not to give my son Jacob Lin nor Daughter Catherine Kelly but any part of the Estate until they or either of them shall have arrived at the age of twenty one years Except what may be deemed necessary for their support. I hereby nominate and appoint my Brother Daniel Kelly Executor and John B Kelly Executors of this my last Will and testament. Ratifying and confirming this and no other as my last Will and testament in testimony Whereof I have set my hand and seal the 26th day of February 1825
