 of Moore being Weak in Body and fare advanced in Years though
 in perfect Mind and Memory and knowing the Uncertainty of
 all Human Affairs and being desirous to settle My worldly
 Business do Make and publish this My last Will and Testament
 in the Words following. In the first place I recommend My
 soul to God and My Body to the dust and My worldly Goods
 as follows I give and bequeath to My son James Curry
 My last Will and all the Appertinances thereto belonging Except
 that My son Will Curry May grant to let free While he lives
 on the part of the Land that I have give him. I also give
 to said James My stile and all the necessary utensils
 for killing - I also give and bequeath to my two Married
 Daughters Mary Willman and Sarah Thomas one Cow and
 half Cal. or ten Dollars in Money when the property is
 divided - and to My daughter Margaret two hoes and Calves
 and to My son John one Cow and Calf and forty Dollars
 to be paid him by My son James to buy him Carpenters
 tools when he is done his Apprentiship at the Carpenters
 Business - To My daughter Margaret Currie one Head and
 Head Cloath - To My son Fido two Head of Hogs that
 came of the stock brought at Grahams store and one
 Horse one Plantain. one pot and one Shille on which
 all the house hold furniture belonging both to the Kitchen
 and dwelling is use to belong to My son James. one half
 of the parsoning utensils to be My son Will when he goes a
 house keeping. My gun to be the property of my son James
 the ballance of My stock of cattle to be Equally divided
 between My sons James and Will after all my last
 debts are paid - I make and ordain My friend Angus
 Kelly Executor of this My last Will and Testament -
 Signed signed published and declared to be My last Will
 and Testament in presence of Archibald ^{his} Curry

 Maintain and Educate our Child John Joseph Degraffincourt
 clear of any charge for the same and in the event of her Marrying
 = ing again My Will is that My property be then Equally divided
 between My wife and Child and that the part allotted to the
 Child be immediately taken possession of by his Guardian and
 that the other half remain in possession of My wife during
 her life and at the death I will and bequeath her part also
 to our said Son John Joseph and his heirs - and there by Manifesting
 and approve My present Robt. Palmer of Chatham County
 the Recorder of this My last Will and Testament - Witness My hand
 and seal this 13th of October 1829
