KNOW all men by these presents that I Michael Russell of South Carolina Planter, Administrator of Cornelious Tyron And have made Obtained and Constituted and Appointed And by these presents do make Ordain Constitute and Appoint one in my place and stead but one deputy Benjamin Tyron of the County of Moore in North Carolina Planter, my true and lawful Attorney for me and in my name and to my use to Ask demand sue for Recover and Receive of and from all and every person and persons whom it may Concern All Debts and Sum and Sums of Money whatsoever due owing or payable unto me as well in my own right as in right of the late Cornelious Tyron And Also for me and in my name and to my use to superintend the sale of a certain tract of Land situate lying and being in the said County of Moore on the North side of Deep River containing four Acres and then Ninety Acres being part of a tract of Land containing four surveys Granted to Edward Griffith and by him conveyed to Gabriel Johnston Esquire formerly Governor of North Carolina and by the last will and testament of the said Gabriel Johnston Part to Sam^l John Johnston one half or Underside Majority of the said four surveys of Land was by the said Samuel John Johnston bargained and sold to George Blair and the said Samuel John Johnston and George Blair did bargain and sell to Philip Alston part of the four surveys including the tract above mentioned and which has been conveyed by the said Philip
