I Rachel Cole of the County of New and State of South Carolina being of sound mind and memory but Considering the uncertainty of my earthly existence do make and declare this my last will and testament in manner and form following that is to say

That my Executor hereof to named shall provide for my body a decent burial suitable to the wishes of my relations and friends and pay all funeral expenses together with my just debts however and to whom no sum owing out of the money that may justly come into his hands as a part or parcel of my Estate I give & bequeath unto my son Benjamin Cole one bed and furniture or the value of the same also one Cow & Calf & two head of Sheep or the value of the same

Item I give and bequeath unto my son William Cole one bed & furniture also one Cow & Calf & two head of Sheep or the value of the same

Item I give and bequeath to my son Benjamin Cole one bed and furniture one Cow & Calf and two head of Sheep or the value of the same

Item I give and bequeath unto my son Benjamin Cole one bed and furniture one Cow & Calf & two head of Sheep or the value of the same

Item I give and bequeath unto my son Richard Cole one bed & furniture one Cow and Calf & two head of Sheep or the value of the same also the sum of fifteen five dollars to be paid by my Executor within two years from the time of my death to my said Son or his lawful representative

Rachel Cole's Will Continued

Item I give and desire is that all the residue of my Estate of any other taking out the debts and legacies above mentioned shall be sold and the debts owing to me Collected & if there should be any surplus over & above the payment of debts, apply & bequeath that such surplus shall be equally divided and paid over to all my Children in equal proportion share and share alike together and to each & every of them their Executors administrators and assigns absolutely forever

And Lastly I do hereby affix my Seal and Appoint my Son Thomas Cole my lawful Executor to all intents and purposes to execute this my last will and Testament according to the true intent & Meaning of the same and every part & clause thereof hereby made King & declaring utterly void all other Wills and Testaments by me heretofore made
