Item: I Lend unto my daughter Purity Meals one negro girl named ~~Ada~~ during her life at her death the said negro and her increase if any to be equally divided amongst said Purity Meals children. I likewise give unto the said Purity Meals one pewter dish and two pewter plates. Item: I Lend unto my daughter Unity Parker one negro girl named Book during her life and at her death the said negro with her increase to be equally divided amongst said Unity Parker's children, I likewise give unto said Unity Parker one pewter dish and two Pewter plates.

Item: I Lend unto my daughter Penney Adkins one negro girl named Doll during her life and at her death the said negro with her increase if any to be equally divided amongst said Penney Adkins children. I likewise give unto said Penney Adkins one pewter dish two pewter plates and one woman saddle. Item: I give unto my grandson Benjamin Pope one feather bed and bedstead and two sheets.

Item: I give unto my grand daughter Nanney Meals one feather bed, bedstead and one sheet.

Item: I give unto grand son Cain Parker one dutch oven.

Item: I give unto my grandson Jennons Hackney one feather bed, two sheets one pair of iron wedges, one ax and one claw hammer.

Item: I give unto my granddaughter Rachel Adkins one cow and two yearlings.

Item: I give unto my grand daughter Betsy Hackney one hoifer.

Item: I give unto my granddaughter Penney Hackney one cow.

Item: I leave all the remainder of my estate to be equally divided amongst my four daughters Sarah Pope, Purity Meals, Unity Parker and Penney Adkins.

Item: I do hereby constitute and appoint Forsworthy Meals to execute this my last will and testament. As witness my hand and seal this 23 day of
