Arrington and my half sister Felicia Arrington. I do further nominate and appoint my brother Robert C. Hilliard executor to this my last will and testament this day and date above written.

I Francis Rackley Sr. of the county of Nash and State of North Carolina, being in a low state of health but of perfect mind and memory calling to mind the mortality of the body and knowing that it is appointed for all men to die do this the twenty third day of June in the year of our lord one thousand eight hundred and thirty seven make publish and declare this my last will and testament in manner and form following to wit first,
Item: I give my beloved son Francis Rackley four hundred acres of land beginning in the great branch and then running up a small branch through the Silas old field from that line strait across south to Thomas Joiners line.

Item: I lend to my beloved wife Cherry Rackley the balance of the land where I now live her life time and then I give it to my beloved son Laman Dew and one negro, all my working tools I leave to be equally divided between my two youngest sons Francis and Lamon Dew. Francis to take first choice. I give to my sons Francis one negro woman

I leave the Bear branch tract of land to be sold and divided equally between my three daughters Selster Pansy, ~~Ward~~ Ward, and Marget Cherry. I want Francis to stay on the plantation untill he is twenty one years old and then he may take his part to himself and go on his own land, or stay with the rest and take care of the family.

I do hereby appoint my son Francis Rackley executor to this my last will and testament. In witness I have hereunto set my hand and seal the day and date first written.
