In The Name of God, Amen, I George ^{Portis} ~~Peter~~ being weak in body and calling to mind the mortality of my flesh do make and ordain this as my last will and testament; and first I recommend my soul to almighty God the maker and ^{preserver} ~~preserver~~ of the same trusting through the merits of my ever blessed Redeemer that he will receive it to himself and my body I recommend to the dust to be buried at the discretion of my friends; and as to my worldly goods which it hath pleased God to bestow on me its my desire that they be disposed of as followeth; I first desire that one cow and calf two sows and pigs and two fat hogs and my gun and my money coming from my fathers estate and all other notes and accompts and all other articles that my sees fit to spare the money arising therefrom go to the paying of debts, and should there not be a sufficiency to pay my debts as much of my land must be sold till there is enough to pay all my just debts and the remaining part of land I lend unto my wife Mary ~~Portis~~ ^{Portis} during her natural life or widowhood, and then I give the said land to my son William ~~Portis~~ ^{Portis} to him and his heirs forever, and the residue of estate which of whatsoever kind I lend unto my wife during her natural life or widowhood and then to be equally divided among my three daughters. Item: I give and bequeath to my grand son Lewis Jackson the land and plantation whereon I now live containing four hundred and four acres one good feather bed two cows and calves one colt that the mare is now with foal with to him and his heirs for ever after the

Item: I give and bequeath to my grandson Newman Richeson five shillings to him and his heirs forever after my wife death.

Item: I will and bequeath that after the death of my wife that the remainder part of my estate to be equally divided to wit Joseph Jackson and Barbara Pope, Sarah Cooper and Rasmie Taylor.

Item: I give and bequeath to my loving son Newman Jackson five shilling to him and his heirs forever after my wife.

Item: I do hereby nominate and appoint Brewery Taylor and Lewis Jackson Executors of this my last will and testament and revoking all former wills and testaments heretofore made ordained and do publish and pronounce this my last will and testament signed sealed and published and pronounced this 25th day of December, 1789.

Item: My will and desire is that my executors hear after named inventory and sell all the property that I am possess with in Nash County at publick vendue for twelve months credit and after my debts be paid the rest to be equally divided between my beloved wife ~~above~~ named Allaminta S. Bottoms, Allevene S Bottoms and Micajah S Bottoms and my will is that my beloved wife above named have her third part the rest be put at in trust for the children. Also my will is that what estate is and belonging to me in Granville County be sold at the same credit and that kept at interest and be equally divided between my two children and my wife. have no part thereof.

Item. I do a nominate and appoint Wm S Bottoms, Jordan Sherrod, Elizabeth Atkins my executors to this my last will and testament in witness whereof I have signed, sealed and pronounced this to be my last will and testament in presence of us this 3rd day of Feb. 1795
