Whitfield all the remainder of my estate including any and every species of property whatever that I now have or ever will have, any interest in and I hereby make and ordain my Brother John R. Whitfield executor of this my last will and testament. In witness whereof I the said Henry C. Whitfield have to this my last will and testament set my hand and seal February 20th A.D. 1867

Whitfield was of sound mind and memory of full age to execute a will and was not under any restraint to the knowledge information or belief of this deponent. And further this deponent says not.
