Item I give and bequeath to my son John York all the household furniture and stock now, in his possession also one negro boy haned green one negro boy named Alexander now in his possession to him andhis heirs forever. Item: I give and bequeath to my loving daughter Mancy Lamon all the nouse hold furniture and steek that/has now in possession the following negroes to wit: One negro girl named Rachell one negro boy named Moses now in her possession also one negro girl named Maty also one negro irl named Harriot to her and her heirs forever.
