Item: I lend and bequeath to my loving wife Margaret Manning the land and plantation where on I now live, one hundred silver Dollars, ten cowes and calves one horse and all my housing stuff, eight head of local hand thirty head of hogs, one negro man named charles, one negro woman named sele, one negro body named bob one negro garl named Nance, one negro boy named Phill, one negro garl named Phebe, one negro boy named Dawson, one negro garl named Dine, one negro gard named Siller one still and worm to her during her life.

Item: I give and bequeath to my loving daughter Sarah Richerson three hundred acres of land it being where he now lives one bed and furniture to her after my wifes death , one negro garl by the name Sock one negro boy by the name of Marchant, four cowes and calves, fifty pounds cash , one hundred pound spice one third part of my puter to her and her heirs forever.

Item: I give and bequeath to my loving daughter Mary Pridgen one tract of land containing, three hundred and twelve acres lying on little Bare Branch one negro woman named Lett. one negro boy by the name of all property boy by the name of Islac, one negro man by the name of Ben one negro woman by the name of Dinah one bed andfurniture one half of my money and one half of all my stock of cattle hogs sheep to one horse to her and her heirs forever.

Item: I give and bequeathte my grand son Mathias Manning one tract of land containing six hundred and forty acres more or less, one negre man by the named of Tom, one negre weman by the name of one negre garl named Dine to him after my wife death and his heirs forever.

Item: I give and bequeath to my grandson Pridgen Manning one tract of land and plantation centaining nine and forty acres, one bed and furniture, one negro boy named Doyson, one negro garl named Siller, one still and werm one negro man by the name of Charles, one negro woman by the name of Sele, one half of my stock of all kinds and half my money to him after my wife death.

Item: I give and bequeath to my grandsen Ele- Manning one negre

boy by the name of Bob one negro garl by the name of Mance to him after my wife death.

Item: I give and bequeath to my grandson David Manning one negre garl by the name of Phebe one negro boy by the name of Phill to him and his heirs for ever. after my wife death.

Item: I will that after my wife's death all the remaining part of my estate to be divided between Sarah Richeson and Mary Pridgen and Pridgen Manning.

Item: I do hereby a nominate and appoint David Pridgen hole executors of this my last will and testament and revoking all former wills and testaments heretofore made or ordained and do publish and pronounce this my last will and testament.
