In the Name of God Amen. I Richard Dozier of Nash County and State of North Carolina being in a low State of health but in my perfect mind and memory do make and ordain this my last will and testament in manner and word following.

First; I lend to my loving wife Elizabeth Dozier Three hundred acres of land Beginning at a large beach on Tar river thence up the said river to the spring but about two hundred yards below the bridge, thence up said branch to the Lowfield field, thence east till it comes opposite to the beach on said river, thence to the said beach or first station; two negroes Eliak and Rachel, five cows and calves fifteen sheats and five sows and pigs, all my horses, ten sheep all my household and kitchen furniture, except my beds and furniture, then I give to her to dispose of as she may think most expedient.

Item: I give and bequeath to my daughter Rebecca Westray one hundred and fifty acres of land it being the land she now lives on four sheep to her and her heirs forever.

Item: I want all my ~~and~~

just debts paid; and all the rest of my estate both real and perishable, which I have not nor do not give away, my will and desire is that be equally divided between my six children, namely, James Dozier, Leonard Dozier, Mary Dozier, Zechariah Dozier, Nancy Dozier and Elizabeth Dozier to them and their heirs forever.

Item: I lend to my wife Elizabeth Dozier my pig and distill during her life and at her death to be sold also Eliak and Rachel to be sold and the money arising from the sale thereof to be equally divided among my children namely James Dozier, Leonard Dozier, John Dozier, Mary Dozier, Zechariah Dozier, Nancy Dozier, Elizabeth Dozier, and Richard Dozier to them and their heirs forever. Item: after the death of my wife Elizabeth my will and desire is that the balance of the property which I have lent ~~to my wife~~ both real and perishable be equally divided between my two sons namely John Dozier and Richard Dozier to them and their heirs forever.

I nominate and appoint my two sons James and John Dozier my sole executors to this my last will and testament in witness whereof I have hereunto set my hand and seal this the 5th day of September, Anno Dom 1829.
