I William Croon of the County of Brunswick and State of
North Carolina, being feeble in body but of perfect mind and
Memory; but considering the uncertainty of my earthly existence
do make and publish this instrument of writing as my last
will & Testament in manner & form following.

First that my executor hereinafter named shall provide
a decent burial for my body after my decease suitable
to the wishes of my relations and friends, and pay the expenses
together with all my just debts out the first money that shall
come into his hands from my estate.

First it is my will that my executor shall sell all my real
estate if he should deem it advantageous to my Estate &
make as good title as I could do my self & divide the
proceeds between my wife Thankful Jane Croon and my
two children Daniel J. Croon and Lena E. Croon
Equally.

Second. I give to my wife Thankful J.
Croon a Negro girl by the name of Wagar during
her life time & at her death the said girl & her increase
is to go to my two children or their heirs in case she should
have any increase.

Third I give all the balance of my Negroes to my two children
Daniel J. & Lena E. Croon. Fourthly, it is my will
that my executor shall sell all my stock of whatever kind

House hold & Kitchen & plantation tools (Except two beds) and Furniture, one for my wife and the other for my two children before married) & if there should be any of the proceeds left after paying my debts it is to be equally divided between my wife & children.
 Lastly I hereby constitute & appoint my friend George W Moore my Executor to this my last will & testament to every part & parcel thereof, hoping he will attend to the same in witness whereof I the said William Croom have hereunto set my hand & Seal this 2^d of the day of June, A D 1859.

Item I give and bequeath to my Grand daughter, Mary Jane Shepard wife of John Shepard eight negroes, viz. City, Morris, Lott, Sandy, Rebecca, George, Peter & Jane to have and to hold, to her her heirs and assigns in fee simple.
