- 2^d. I give to each of my sisters & Mother at my death the sum of Fifty Cents each and no more

And lastly I do hereby constitute and appoint my beloved wife Elizabeth Lassiter Executor to this my last will & Testament in the year 1856. 9th January.

I give and bequeath to my son James M Murray One Cote of Oxen and two Carts all my stock of hogs and all my Crop of all kinds of which I may be possessed at the time of my decease

I give & bequeath to my daughter Susan Murray my horse and riding Chair also all the Household and Kitchen furniture of which I may be possessed at the time of my decease to be hers and at her disposal absolutely forever

I give and bequeath to my son Aaron William Murray my Negro man Colled little Jim to be his and at his disposal absolutely forever

I give and bequeath to my son Guilford S Murray my Negro woman ^{named} Thusey to be his and at his disposal absolutely forever

My desire will is that my stock of Cattle (except the Oxen mentioned in foregoing bequests) be equally
