Item 2^d I give and devise to my beloved wife Margaret Peterson three hundred & two acres of land, it being the tract of land whereon I now live, containing my house and plantation, to have and to hold to her the said Margaret Peterson for and during her natural life in satisfaction for her & in lieu of her dower & third of my lands Also my two negroes Viz Sam & Harriet for & during her natural life, and after her death I give Sam to my son Moses Peterson and Harriet to my daughter Priscilla Ann Williams and the children born of her body, the increase of Harriet I reserve during my life. I also give to my wife Margaret three Cows & Calves (her choice) one yoke of Oxen and Cart, one horse, bridle & Saddle, three year old lamb, two sows and pigs, six year old Hogs, two Stock Bees, one third part of my house hold and Kitchen furniture for and during her life and after her death to my daughter Elizabeth Jane Drew wife of Anthony Drew

Item 3^d I give and devise to my daughter Mary Corbitt heirs ^{the sum of} one dollar

Item 4th I give and devise to my daughter Susan Corbitt one feather bed and furniture

Item 5th I give and devise to my son William Peterson a negro boy named Lawless

Item 6th I give and devise to my son Timothy Hatchett Peterson one dollar

Item 7th I give and devise to my son Aaron Peterson One hundred acres of land called the reedy Skirt lands, adjoins the lands of R Murphy and others, said piece or parcel of lands contains one third of my land and was deeded to him some years ago.

Item 8th I give and devise to my son Moses Peterson a negro boy Sam after the death of my wife.

Item 9th I give and devise to my daughter Priscilla Ann Williams my negro woman Harriet after the death of my wife

Item 10th I give and devise to my son John Peterson my negro girl Lucrecia now in his possession and one third part of the residue of my estate after the distribution agreeable to this will.

Item 11th I give and devise to my daughter Elizabeth Ann Drew my negro's Hamah & Jude and their increase, also give her the Stock and household furniture & kitchen furniture named in item 2nd of this my will and given to her mother during her life and also my plantation whereon I now live containing 302 acres, to her and her heirs forever in fee simple

Item 12th The residue of my estate not otherwise disposed of, I leave to be sold by my executors and equally divided between my wife Margaret and son John and daughter Priscilla Ann Williams after paying my just debts and funeral expenses. And lastly I do hereby nominate and appoint my trusty friend William Robinson my lawfull executor to all intents and purposes to execute this my last will & testament according to the true intent and meaning of the same and every part and clause thereof hereby revoking and declaring utterly void all other wills & testaments by me hitherto made.
