William Brittle Will

In the name of God amen I William Brittle of the County of North
ampton in the State of North Carolina knowing that it is appoint-
ed for all men once to die & make this my last will & Testament
as follows.

Item I give & bequeath unto my wife Sarah one mare & colt unbroken
one bridle & saddle one box of furniture & if in case my wife
Sarah shantors marry my wife & desire it that herfaut said
Negro fall to me a yoh Brown to him thishins forever.
And my further will & desirte I do appoint Jeptha Brittle my
whole estate executors of this my last will & Testament.
and witness hereunto set my hand & seal this 18 of
February 1781

Robert Pele Will

I Robert Pele of a W.D. Thamptow family in this state
hereinafter being aged & infirm of body although believed
to be the all wise disposer of all things of sound & undi-
sposing mind & memory & calling to say mind that is
appointed to me out to die do make & ordain this
my last Will & Testament in manner & form
following namely -

Firstly I give & bequeath unto each of my fine clarsy chil-
dren, viz, Robert & Isaac Pele, Elizabeth Bryant, Mary
Hallowell & Sarah Newson whatever they are already pos-
sessed of out of my estate to each of them their heirs and
successors forever.

Item It is my will & desire that all my Negroes, to wit: James,
David & Caesar, Dinah & her young child new boy, Sister Nelly
Sime, Fresses & all the increase of the sd Dinah & her four
children if any. They shall have their freedom if under the
Laws of the Land should a master of them having that privi-
lege freely, clearly & absolutely until which time it is
my will & desire I do hereby give & bequeath unto my
fine children above named my two negroes James and
David & that the profit arising from their labor be equally
divided. Item - provided they dont sell her or remove her
remote from their wives or contrary to their choice -

Item I give and bequeath unto my son David Pele & my two nie-
ces Lord Cornelius Bell and my Daughter Judith,
Rachel & Celie my six Negroes Caesar & Sister Dinah,
Nelly Sime, Fresses and their increase if any to be equal-
ly divided according to values unto them their heirs & assigns
until the days above a master of their freedom -

Item I give & bequeath unto my daughter Sarah Newson one
bed & furniture to her & hers forever -

Item I give & bequeath unto my daughter a black jennet my
horse, & my riding saddle to her & at her disposal -

Item I give & bequeath unto my two daughters Rachel & Celie
