

David Winborne's Will

In the name of God amen, I David Winborne of No Carolina in the County of Northampton, being very sick & weak in body, but sound in mind & of good & disposing sense & memory calling to mind the uncertainty of this transitory life am willing to make my Will & dispose of my Estate as follows.

First of all I bequeath my soul to God that gave it me & my body to be buried at the discretion of my Executors, my funeral expenses discharged & debts paid, I bequeath my Estate as follows.

Item I give & bequeath to my wife Elizabeth Winborne one cow & calf like wise one steer & also give to my wife three head of sheep one saw & eight stools one bed & furniture & I assign to my wife Elizabeth Winborne the use of one negro girl named Prip for the term of eight years the whole of my brother Skewins give to my wife & also two Iron pots one case of knives & forks one linen wheel & a wooden wheel one chest & trunk two chairs.

Item I give & bequeath unto my son Saml Winborne the Plantation whereon I now live the land belonging to it to him & his heirs forever as touching the plantation I have already given to my son my Will is that my wife Elizabeth Winborne may have the use of the sd plantation during her life if it be god's will that my wife be safe & healthy & of the child unborn I give to it one negro girl named Prip & her increase for ever my Will is that if either of my children die before they come of age the other shall have his property. my Will is that the remainder of my perishable Estate may be sold & the money equally divided between my two children. And I do leave James Winborne & my wife Elizabeth Winborne Executors of this my last Will & Testament & allowing of any other Will or Wills made by me confirming this & no other to be my last Will & Testament. - Item I give & bequeath unto my son James Winborne the Plantation whereon I now live the land belonging to it, to him & his heirs forever attaching the plantation I have already given to my son my desire is that my wife Elizabeth Winborne may have the use of the said plantation during her life if it be good advice that my wife be kept by him & if of the child unborn I give to it one negro girl named Prip & her increase forever my desire is that if either of my children die before they come of age the other shall have his property. my desire is that the remainder of my perishable Estate may be sold & the money equally divided between my two children. And I do leave James Winborne & my wife Elizabeth Winborne Executors of this my last will & Testament making & allowing of any other will or wills made by me confirming this & no other to be my last will & Testament.
