I likewise ^{constitute} & appoint my Son Edward Rowell my Sole
 Executor I do hereby revoke & disannul all & every former
 testament named & called & hereafter signing & confirming
 this no other before my last and last testament, In witness whereof
 I have ~~hereunto~~ set my hand & seal this day & year above written & the
 Sign & Seal delivered in presence of Samuel ^{his} Rowell & Samuel
 Jos. Smith, Jos. M. Chipman, William ⁱⁿ Vaughan mark

Northampton County, August Court 1784.

The within written Bill of Ammut is now over our rebellion
in East of prison in the path of St. John Snipes, one of
the subscribing citizens there at this same time Frederick
Nash was a liquid dealer there, which in motion
was ordered to be Confiscated & received.

In the Name of God Amen. I James Hall of the County of Amelia
being in perfect heat of Mind and Memory, thanks be praised
for the same, but knowing the uncertainty of life do make
this my last will & Testament in manner & form as follows,

First I give my soul to God who gave it me, I my body to be buried at
the discretion of my executor hereafter named

Then I gave the quittance to my son James Hall & to his heirs & assigns forever two hundred acres of land which does include the plantation he now lives in with two negroes upon an m. and that & all his increase, except one negro girl I have already given with his increase to my daughter Ruth.

Then I gave Higumath to my Daughters Francis & her Sister & a pair
for ever one Negro Jost named Sabin with his Amaranth & one
Saddles & Trunk his & his sister and the one with all children
Furniture &c.

I have my self & mine, my dear, I believe my wife should have the whole use of
 my Carolina plantation bought formerly of Mr. John Ogle & three
 hundred acres, of land adjoining thereto, as also he, Choise of two
 of my best Negroes, as also what house hold goods she will
 please to take, such as beds, furniture, pots, kettles, and any other
 things likewise what stock of Cattle, Horses, Mares, & sheep. & so
 all her during during her natural life, and at her decease
 my said wife that I have left my wife should be equally divided be-
 tween my three sons vizt, Theodore, William & Benjamin
 & none of my other Children to come in for any part left
 my wife, but to descend to Theodore, William, Benjamin
 to them & their Heirs forever.

Now My dear Valer is that all my said plantation I have been able
to sell the money appropriated to the payment of my law expenses

Item My will & desire is that all my Negroes & my other Estate not already mentioned be Equally divided between my three Sons, Third son, William & Benjamin to them & their heirs & assigns forever.

Then I leave my dear beloved wife & my son Saml. Hall my whole
Estate & of this my last will & Testament as a fitting my hand
