after the decease of his widow of his mother
the land & plantation as above mentioned
to him and his heirs forever lawful begatton
of his own body but if he shoud die with
out an heir of his own then the former
land and premises to be sold the money
to be equally divided amongst all the rest
of children to wit William Norton Francis
Norton John Norton Margaret Norton Ann
Norton Sarah Norton & Hannah Norton
& lastly I do devise & ordaine that the remainder
part of my Estate after the death or widow
hood of my wife to be equally divided among
all my children above named

Item I devise William Jason & Prudent Measur
executors of this my last will & testament
the 18th day of July 1778

county Hampton and province of North Carolina planter
living with and within body but of mind and
disposing mind and memory thanks be unto Almighty
go For the same to make and ordain this my
just will and testament in manner of writing
following that is to say first & principally I command
my selfe with the hand of Almighty god who gives
it strength to receive the same again at the last
day righteous and free pardon of all my trespasses
After my just recompence my kindred God and Saviour
Jesus Christ and my body I commit the Earth to
be decently interred at the discretion of my executors
hereafter mentioned mentioned and as for such
worldly goods and chattels lands and tenements
as I have here placed Almighty god to bestow upon
me I give and desier and appoint the same as
followeth. I will that all my just debts and
funeral charges be paid and discharged

Item I lind to my beloved wife Christiane Chapman
all my estate to her in trust her widow hood or till
my children comes of age and if in case that
my wife shoud live a widow after my children
comes of age

Item I lind my Negro wench Bridget and my Newman
with money negro much lidd and six head of cattle
and six head of sheep and one mare one leather bag

three hours and four plates and one dish One Bacon
one duck and the use of my main plantation and
half the land in during his residence

Item I give and bequeath to my son William Sanders
my negro man mill and my negro woman bid and
her increase and my negro boy and all other
united these twenty acres of Land to him and
his heirs forever also One hundred & Twenty pounds
Virginia money

Item I give and bequeath unto my son Solomon Sanders
my negro boy Slave and my negro gal bid and my
negro gal Isab and my negro woman Brigit
Also my main plantation with three hundred
and twenty acres of Land to him and his heirs
forever

Item I give and bequeath all the rest of my estate to
be Equally divided between my two sons William
and Solomon Sanders after my wife's marriage
and I do hereby nominate and constitute my
friend Peter Brown & Thomas Price to be
my true & lawful executors & seal of this
my last will and testament bearing witness thereto
and disowning all former & other wills and
testaments written heretofore by me made and
fixing this and every other to be my last
will & testament in writing whereof I have
set herewith my hand and seal this 7th of Nov
1778 signed sealed & published pronounced delivered
by Solomon Sanders as of his body or ill & testament
in the presence of Jas. Vinton Edwin Bridges

In the name of god Aluid I Mary Lovy of
Newbern County Province of Carolina being
with & weak in body But of a despatching mind
I now make this to god first & knowing that
it is appointed for all men to die I do make and

all other wills or wills made by me before this and
all what worldly goods it bath been god's will to
bestow on me I give & dispense of as follows

Item I give to my Brother Littleton Long One negro
woman named Rose one fitter Bed & all the furniture
belonging thereto to him & his heirs & assigns forever
Item to my Son my Brother John Long Daughter
my saddle & the horse belonging thereto & Riddle also
one pair of Stays to his heirs forever

Item I give to my friend Samuel Burkitt the sum
of Twenty pounds proclamation money to him and
his heirs forever

Item I give the above mentioned bedchuck Burkitt
wife one Cordial One other gown one pair of
new Cloth shoes &c

Item I give to Sarah pajad three girds one Cotton gird
One quilt &c

Item I give to my sister Ann Long one pair of fine one
Cotton girds & quilt &c

Item I give to my sister Rebecca Long One blue gird one
Cotton gird One blue Cambric gird one Black & one
One Duffet One blue vest One Black vest &c

Item I give the remaining part of my wearing apparel
to my sisterly Anne & Ruth who to be equally divided th

Item I give to my sister Rebekah Long all the remaining
goods of my Estate to her or heirs & assigns forever &

Item I have the power of my Executive to sell what part
of my sister Rebekah Long Legacies as they stand
