one negrow woman called Ruth after my wife  
widow woor.

I Begun unto my son Benjamin Taver & Charlotte  
Taver our one negro girl called Sam after  
my wife widow woor

I Begun unto my two sons Micajah & Thomas Taver  
one negrow man call'd Sam after my wife widow  
woor.

I Begun unto my Daughter Silvia Taver one  
negro girl call'd Anna.

I Begun unto my Daugtter Taver one Negro boy  
call'd David.

I Begun unto my wife Lucy all my Stock and houses  
hova good During her abidow wood & after her died  
hova wood all the Stock & house hova good to be  
equally divided among my four Sons if they can agree  
to divide among them & if not they must sell  
it at public sale & divide the Money  
whereunto I set my hand & seal this day & date  
above mentioned James his Taver

Northampton County in the province of North Carolina  
being at present sick and weak of body but of sound  
mind and memory thankes be to God therefore but calling  
to mind the mortaliaty of my body do constitute this my  
last will and Testament in manner and form fol  
lowing that is to say first and principally I Commit  
my soul into the hands of God hoping to have full  
and free pardon of all my sins and to inherit Ever  
lasting life as for my body I Commit it to the  
Ground to be Buried in a Christian manner  
at the discretion of my Executor here after named  
and as touching all such Temporal Estate asset herch  
she Almighty to bestow upon me I give & dispose the net arfallow

I give to my grandson Samuel Bryan one dollar  
I give and bequeath all the rest and residue of my whole  
Estate within Doors and without Doos to be Equally  
divided according to Equality between my two Daugh-  
ters Elizabeth Brown and Manning Brown and I do  
constitute my trusty friend Daniel Dickinson and  
John Dickinson my whole and sole Executors of this my  
last will and testament Drawing and Making  
void all other wills heretofore made by me in  
Witness whereof I have unto set my hand and affix  
my seal this thirty day of July 1773.

### Harmon Farmer Will

In the name of God Amen I Harmon Farmer of the County  
Northampton in North West Parish living in good health  
thanks be to God but duly Considering that it is appre-  
ciated and for all men to die I make this my last will  
and testament in manner and form as follows I think  
proper as for my worldly Estate where with it hath ple-  
ased God to bless me with I give and dispose of the  
same as follows with first I give and bequeath the use  
of my Plantation wherewh I now dwell Contain-  
ing one hundred acres of land thereto belonging  
to the same more or less to my youngest son Robert  
Farmer to him and his heirs forever Secondly I give  
to my son Frederick Farmer my Negro Boy Charles  
to him and his heirs forever likewise my mare  
to my son Frederick Farmer also with my Negro
