Benjamin Johnson's Will

In the name of God Amen Benjamin Johnson
of Northampton County State of North Carolina being weak & feeble
in body but of sound mind & memory, being assisted with a small portion
of his Neighbors, do make and Ordain this my last Will & Testament
disannulling all other Wills before made by me, this 2^d day of September in
the year of our Lord one thousand eight hundred & five in
Manner & Form as follows:

Item I Give to my Daughter, Elizabeth Johnson one Quarter Part of my Estate to
Laurel Boon for ever.

Item I Will & desire that my Land & sold also my Stock of Cattle, with my House
& Lot & Furniture plantation & other and what ever may be deemed my
Estate except my Negroes, to be sold, and the money arising from such sale
to be put on Interest for the support of my Children;

Item I Will and desire that my Negroes be hired out annually until my young child
arrives to the age of Twelve Years;

Item I Will and desire that when my aforesaid child arrives to the age of Twelve
Years, that the whole of my Estate be equally divided among my children
by the names of Elizabeth Johnson, Elizabeth Johnson, W. Johnson, Polaj
Johnson, Martha Johnson, Robert Johnson, Frederick Johnson;

Item I do hereby appoint my worthy Friends Nathaniel Chamberlayne, Frederick
Chamberlayne and William Stewart & Charles Stewart who shall be Executors of
this my last Will & Testament as Witnesses. I have hereunto set my
Hand & Seal the Day & Year above Written.
