In the name of God, Amen, Richard Parker of Northampton County, State of North Carolina, being very weak in Body and Mind, but of sound disposing Mind and Memory, thanks be to Almighty God for it, and calling to mind the shortness of this transitory life, and knowing it is appointed for me once to Die, I do make and Ordain this to be my last Will & Testament in manner and form as followeth: Vizt. I recommend my Soul to Almighty God that gave it to me, and my Body to the Earth from whence it was taken to be buried in a Christian like manner according to the direction of my Friends hereafter left behind, I do trusting of worldly Estate, such as it hath been please Almighty God, to bless me with, I do give and dispose of in manner and form as followeth: Vizt. I leave three Parts of Land (one by the name of Bear Taverns tract I purchased with Isaac, and one called Watling's tract) to be sold and the money arising therefrom to go to the use of paying my Debts.

Conjuring

I give and bequeath to my Daughter Rebecca Parkes five Negroes Annan, English, Bob, Jacob, & Matt to her and her heirs forever.

I leave to my beloved Wife Sally Parker the use of five Negroes (Henry, Charles, Winny, Liddy, & Kate, and Tom, during her natural life and after her Decease) I give the said negroes to my Daughter Rebecca Parkes to her and her heirs forever.

I give and bequeath unto Richard Parker Parkes one Horse, Biddle and saddle, and one hundred Pounds in Cash to him and her heirs forever.

I leave my negro slave called Matt to be sold free, and have the liberty of living on my Land during her life.

I leave all the remaining part of my Estate, After already given away both Real and Personal to be equally divided between my beloved Wife Sally Parker, and my Daughter Rebecca Parkes, during my Wife's life, and after the death of Wife I give all the said property which is left to be divided between my Wife and my Daughter, wholly to my Daughter Rebecca Parkes, to her and her heirs forever. Also I do hereby constitute and appoint James Brown (Esq.) James Carr, & John all Bonford my whole Executors of this my last Will & Testament, this annulling, disavowing, and Reversing any other Will or Wills heretofore made by me or in my Name, attesting & Confining

this to be my last Will & Testament, In Witness whereof I have signed, sealed, Published, Renounced & Declared the same this fourteenth day of November in the Year of our Lord one thousand eight hundred and thirty.
