In the Name of God Amen I Lewis Daughtry of the County of Northampton & State of North Carolina being my sick and weak at this time do hereby to mind the Mortality of my Body and knowing I must Die yet being of sound Mind and Memory thanks be to almighty God for it and his benediction and Blessing this my last Will and Testament in Presence and Presence following that is to say

I do hereby recommend my Body to the ground to be buried in a decent Christian like Manner and my soul to God that gave it. I do wish according to his Will and as Touching all my Real Estate as do hereby bequeathed to be divided among me I give and bequeath in Presence and Presence following that is to say

I give unto my Daughter Mary Daughtry one fourth of my Estate

I give unto my daughter Lucy Daughtry one fourth of my Estate

I give to my Daughter Selby Daughtry one fourth of my Estate

I give to my daughter Sally Daughtry all the residue of my Estate real and personal within and without Doors Land and all during her natural life or during her Widowhood and Eighty Years to be equally divided after her decease my land of one hundred and Eighty Acres to be equally divided between my four sons William and Thomas and John and Samuel leaving the Plantation whereon I now live to Samuel my youngest son with an equal part of Land with the residue then all the remainder part of my property to be equally divided between the whole of my Children then living and I do constitute and appoint my two sons William Daughtry and John Daughtry to be my Executors to this my last Will and Testament making void all other Wills in which I have hereunto set my hand and seal this 5th day of March 1803

Hubert Stafford Will

In the Name of God Amen I Hubert Stafford of Northampton County being of sound Mind and Memory do hereby this my last Will and Testament in Presence and Presence following that is to say

I give unto my Wife Elizabeth Stafford one third of my Estate

I give unto my Wife Elizabeth Stafford the use of all the residue of my Estate both real and personal during her life or Widowhood and until my daughter Lucinda Stafford comes to the age of Eighteen years or Marriage for the use of raising and maintaining my said daughter Lucinda Stafford and after which time should first take Place the death of my Wife or Marriage or my daughter Lucinda arriving to the age of Eighteen I give all the Estate then to my Wife as above mentioned to my daughter Lucinda Stafford with the residue of the same but in case my daughter Lucinda Stafford should die without any lawful issue all the Estate given to my daughter Lucinda I give to be equally divided between my surviving Children

I do appoint my Wife Elizabeth Stafford & John Davis Executors to this my last Will and Testament making void all other Wills in which I have hereunto set my hand and seal this 10th day of November 1797
