In the name of God Amen, I Samuel Irvin of the State of North Carolina and County of Northampton being now under a severe affliction of body but of sound mind and perfect memory, thanks be rendered to God for the same, and knowing that it is appointed for all men once to die, do make and ordain my last Will & Testament in manner following VIZ Just I send unto my beloved wife Sarah Irvin all my lands and plantation whereon I now live during her natural life or widowhood.

2^d I send unto my above mentioned wife all my negroes, namely Ayfeld & Selah & Allen & Mason & Penny & Carmelak during her natural life or widowhood.

3^d I give and bequeath unto my son William Irvin all my lands and plantation whereon I now live and also my negro boy Allen (Whom young have to him & his heirs forever.

4th I give and bequeath unto my daughter Peggy Lamberton my negro girl Sewly and negro Boy Mason to her & her heirs forever.

5th It is my Will and desire that the balance of my negroes not yet given, them and their increase be equally divided betwixt my two daughters Elizabeth Irvin & Maryan Irvin by them to be freely possessed & enjoyed.

6th I give and bequeath unto my son John Irvin one feather Bed of furniture to him & his heirs forever.

7th I send unto my beloved wife Sarah Irvin all my stock of all kind and my household & kitchen furniture & plantation utensils of every description during her natural life or widowhood.

8th It is my will and desire that all my property of all kind, not yet given should be equally divided among my four daughters namely, Nancy Irvin, & Peggy Lamberton and Elizabeth Irvin & Maryan Irvin and my son Henry Irvin by them to be freely possessed and enjoyed.

9th I do hereby constitute and appoint my son William Irvin and my son in law John Lamberton the whole and sole Executors to this my last Will and Testament.

Mary Branch's Will

In the name of God Amen I Mary Branch of the County of Northampton and State of North Carolina being in sound mind and memory thanks be to God for the same do make and ordain this my last Will and Testament in manner and form following.

Imprimis I send unto Martha Roberts wife of Benjamin Roberts the following negroes vizt Sarah, Phill, Jimmy, Lender, Venus, Jacob, Jimmy, Nancy, Peter, Tom, Jack, Malvina, Selina, Betty, Sam, Cain, Sarah, Elly during her natural life, and after her death I give the aforesaid negroes to her two children Mary Ann Roberts and Thomas Vaughan Roberts and their future increase to be equally divided between the two above named children when Mary Ann Roberts comes of age or money if either the above named children should die before they have a lawful heir, my desire is the living child should have the above named in or negroes and their future increase if both the above named children should die without a lawful heir of these body my will and desire is that the above named negroes should be equally divided between my two nieces Rebecca Vaughan and Sally Vaughan daughters of James Vaughan.

Item I give and bequeath unto Sally Vaughan daughter of James Vaughan the following negroes (vizt) Molly, Betty, Anthony and their future increase one bed and furniture one clock and

riding chair, one black Walnut Table and half dozen silver Tea spoons, one set of chairs to her and her heirs forever.

I then I give and bequeath unto my Nephew James Vaughan son of William Vaughan next, my negro man named Tommy and my Buckskin horse called Beggar to him & his heirs forever.

I then I give and bequeath unto Henry Briggs Vaughan son of William Vaughan one negro girl named Mary daughter of Nancy to him & his heirs forever.

I then I give and bequeath unto my niece Ann. before one negro girl named Pats and her heirs increase to her & her heirs forever.

I then I devise for my negro woman Sal to be left in the hands of Benja: Roberts to be free for her to maintain herself and should she get not able to maintain herself, for Benja: Roberts to maintain her out of my estate; also Henry to be maintained by Mr. Roberts until he gets able to be bound out in consequence of what I have given his children.

I then I give to my negro woman Sall sixty dollars to be raised out of my estate hereafter mentioned to be sold.

I then, my further Will and Desire is that my stock of all kinds not before given away also the whole of my crop of all kind be sold to the highest bidder for nine months credit the money arising from the sale of the same to pay my just debts with, and the legacy above given to negro Sall, and the balance if any arising from the sale, I give and bequeath unto Rebecca Vaughan & Francis B. Beale to be equally divide between the above named children.

I then I do hereby appoint my friend Benja: Roberts & then Vaughan my whole and only Exors. to this my last Will & Testament hereby revoking all other Wills by me heretofore made. As witness my hand and oral this the 20th day of Decer 1810

Samuel Lawrence's Will

In the name of God amen I Samuel Lawrence of Northampton County and State of North Carolina being in reasonable health and sound disposing mind and memory, thanks be given to Almighty God for the same, and calling to mind the mortality of my body and knowing that it is appointed for all flesh once to die, do make and declare this my last Will and Testament in manner & form following.

I therefore first recommend my soul into the hands of Almighty God who give it me, relying on the meritorious blood of my blessed Saviour to have full remission of all my sins, and as to what worldly Estate it hath pleased Almighty God to bless me with in this life I give and dispose of the same in manner & form following to wit.

I then I leave to my beloved wife Mary Lawrence during her natural life the land and plantation I now live on and also four negroes, Wm. Jacob, Solomon, Mary and Kate and also one half of the stock of all kind, at the plantation whereon I now live together with one half of my plantation utensils household & other furniture.

I then I leave to my beloved son James Lawrence, Moses, Sam. Isaac, young, Luke, Venus, and also Jacob, Solomon and Kate after my wife deceased to him during his natural life and after his decease I give the said eight negroes to be equally divided amongst all his heirs lawfully begotten of his body to them & their heirs forever.

I then I give to my son James Lawrence my land in the State of Virginia near South Quay also my land near Princeton that I bought of Esom Liles and my stock of all kind on the Princeton Plantations and two negroes Luke and Greedy to him & his heirs forever.

I then I give to my daughter Polly Briggs wife of Sipe K. Briggs three negroes, to wit, Jack, King and Dorcas and also negro woman Mary after my wife deceased I also give her the remaining
