Tice. I give to my son James R. Tice one negro boy named Charles to him and his heirs forever I give to my son Wiley Tice one negro man named Ellick to him and his heirs forever I give to my son George Tice one negro man named Tom (Barrell) to him and his heirs forever. I give to my son Charles R. Tice one negro boy named Fox to him and his heirs forever I give Wills Taper one dollar to him and his heirs forever I do make and ordain George and Charles R. Tice my sole executors of this my last will and testament. I do utterly revoke and disannul all and every other will and testament by me made. In witness whereof I have set my hand and seal this 22nd day of November one thousand eight hundred and sixteen

I James Maddox of the County of Northampton and State of North Carolina, being in a full State of Health but in perfect sound mind and memory do make and ordain this my Last will and Testament in the following manner and form (to wit) Item, I give & bequeath to my Brother Mary Maddox Three Hundred & fifty dollars to her and her heirs forever also a note which I hold in my hands against her. Item, I give to my nephew, James

Maddox Seventy five dollars to be applied for the benefit of his education at the discretion of my executor hereafter named. Item, I give to my nephew John Maddox three hundred and fifty dollars out of which one hundred and fifty dollars to be applied for the benefit of his education at the discretion of my executor the other two hundred to be paid to him when he arrives to the age of twenty one years by the executor as above named, also one bed and furniture to him and his heirs forever. Item, I give to my nephew James T. Maddox my small gun to him and his heirs forever. Item, I give to my nephew Henry W. Maddox my large gun to him and his heirs forever.

Item, I give to Nathaniel T. Maddox my Market bargain to him and his heirs forever. Item, I give to Anderson T. Maddox my chest and two trunks to him and his heirs forever. Item, I lend to Mr. brother William Maddox just all my lands which I am possessed with as per deeds during his life at his desire to be sold and equally divided among the whole of his children, also after paying my just debts the residue and remainder of my estate not yet named I give and bequeath to my above named brother William Maddox to him and his heirs forever. I do hereby nominate and appoint my brother William Maddox, executor of this my last will and testament. In witness whereof I have hereunto set my hand and seal this Twenty Ninth day of December one thousand eight hundred and Eighteen.
