Item 3^d I lend to my sister Minnie G. Blow during her natural life or widowhood all my estate. Item 4th I give and bequeath to my niece Sarah Blow after the death or widowhood of her mother Minnie G. Blow all the above estate land her mother, (except the 2^d Sarah Blow should die before she arrives to the age of twenty one years of leave a lawful heir of her body in which event my will and desire is that my estate be equally divided among all my brothers and sisters. Lastly I nominate and appoint my worthy friend James J. Sykes executor of this my last will and testament, in witness whereof I the said Thomas Rivers have to this my last will and testament set my hand and seal the day and year above written.

Northampton December Court 1816 This last will and testament of Thomas Rivers decd was exhibited into Court and proved in due form of law by the oaths of Robert G. Farham John B. Pebles and Andrew H. Walker the subscribing witnesses thereto and was ordered to be recorded: time being allowed the executor therein named to qualify, and at a Court held in the County of Northampton the first Monday in March 1817 James J. Sykes the executor named in the preceding will came into Court & renounced his right of qualifying thereto: whereupon administration of all and singular the goods and chattel rights and credits of the said Thomas Rivers decd is granted to the said James J. Sykes and John Lockhart, who together with Payton Maughon and James Barrett entered into & acknowledged their bond in the penalty of four thousand dollars, conditioned as the law direct.

Item I give and bequeath unto my brother Willis Dole's two eldest children namely Wilkins Dole and Wilks Dole each twenty five dollars a piece. Item I give and bequeath unto my brother Willie Dole's two children namely Demarkus Dole and Joe Dole each twenty five dollars a piece. Item I give and bequeath unto my brother Epam Dole's two children namely Arthur James Dole and Sally Dole twenty five dollars each a piece. It is my will and desire that all my estate not hereby given away should be sold at public auction on a credit of twelve months by my executors whom I appoint, and after paying all my just debts I desire that my whole estate that I have not given away above should be equally divided between the above eight children namely Littleberry Long Polly Long Wilkins Dole Wilks Dole Demarkus Dole Joe Dole Arthur James Dole and Sally Dole and my will is if either of the aforementioned children should die without a lawful heir the surviving ones should heir his or her estate, and I hereby make and ordain my worthy friend Epam Hollamson just and my nephew Littleberry Long executors of this my last will and testament.
