As for the worldly goods, that it has pleased God to bestow upon me, I live in the following manner and form viz.

- Item 1. I lend unto my beloved wife Rebecca Bourn an negro man named Saunt also an negro woman named Clary and her increase, also one bed of furniture also a negro girl named Eliza, all of which I lend unto her during her natural life or widowhood; then to be equally divided between Lucey Bourn, Rebecca Bourn, Mary Bourn, William Bourn, and Anna Bourn, all of which are my sons and daughters, to them and their heirs forever.
- Item 2. I live unto my son William Bourn, one negro boy named Sam, also the horse black saddle, cow, sheep, two pigs which he has had heretofore, to him and his heirs forever.
- Item 3. I lend unto my daughter Martha Brown one negro boy named Anthony, also the sum of eighteen dollars in cash, all of which I lend unto her during her life and then to be equally divided between all of her children then living, to them and their heirs forever.
- Item 4. I live and bequeath unto my son Edwin Bourn, the tract of land, that is purchased of Benjamin Marr, on horse, cow and two pigs, and bed of furniture, also an negro girl named Clary, all of which I live unto him to his heirs forever.
- Item 5. I lend unto my daughter Therby Mangley, one bed of furniture on cow

and Calf, one Sow and pigs, also one negro woman named Olive and her increase, all of which I had unto her during her life, then to be equally divided between all of the children to them and their heirs forever.

Item 1 I Give and bequeath unto my daughter Temperance Kittle, one Bed and furniture, one Cow and Calf, also one negro woman named Phoebe, and increase also one negro child named Fildow, to her and her heirs forever.

Item 2 I Give and bequeath unto my daughter Lucy Roon one Bed of furniture, one Cow and Calf also one negro Boy named Frank, to her and her heirs forever.

Item 3 I Give and bequeath unto my son Cape Roon, the Tract of Land that I bought of Isaac Parker, adjoining I Whiles, one Bed and furniture, also one negro Boy named Henry, to him and his heirs forever.

Item 4 I Give and bequeath unto my son Benford Roon, all of the Tract of Land that I purchased of Brister Capiteo, one negro boy by name of Isaac to him and his heirs forever.

Item 5 I Give and bequeath unto my daughter Mary Roon one negro girl named Leah, also the sum of forty Dollars in Cash, to her and her heirs forever.

Item 6 I Give and bequeath unto my son Willie Roon, one negro man named Astor also the Tract of Land that I have been in (by) the part that I bought of Arthur Griffiths, which I had given him after his mothers death, also the Tract of Land that I purchased of Edward Claver, to him and his heirs forever.

Item 7 I Give and bequeath unto my daughter Anna Roon, one negro man named Eum, to her and her heirs forever.

Item 8 It is also my will that all the residue of my Estate of whatever kind to be sold and after paying all of my just debts, to be equally divided between my wife and all of my children.

Item 9 I do nominate and appoint William Roon of Edmund Jacobs sole Executors to this my last Will & Testament and hereby making all other Wills by me made.
