In the name of God Amen This Beauteous Man and Signs this the first  
day of October in the year of our Lord Eighteen hundred and fifty two being the  
test John H. Houghlin of the town of Southampton N. State of South Carolina  
being sick of body but of sound mind and memory certe to be very well  
and I do so say done that my slaves in unengaged hands  
will be sold out of my estate the money arising therefrom to said road  
man (which) shall be left me the money arising therefrom to said road  
to my father John Houghlin to be appropriated by him in the purchase  
of negroes which I wish to be so used out by him immediately and now  
I am of the most property to go to my beloved wife only a sum  
enough but used to the education of my children and such other  
as his discretion may think best I desire that Master Guy in the  
state of Pennsylvania be made my agent in the sale of  
my lands there and other property of mine and that he shall have  
full power to make a valid legal sale or sales to him  
being the following in regard to the lesser one third of the land  
the money to be paid down at the time of sale and when 1000  
times to be paid in annual instalments by me and his heirs  
the sum above being left off to him by my will my  
will that my boy Amos and Mira be sold by my executor and all  
other property which he may think convenient for the plantation  
or where I now live for the purpose of paying my debts  
It is my desire that if my wife wishes to keep house and  
property as is necessary for that purpose shall be set apart by  
my executor for her but be sole of it to her legate  
that property my executor for her but be sole of it to her legate  
5th I give and bequeath unto my beloved wife my good house  
and waggon etc It is my will that all my property now  
before mentioned be equally divided between my beloved wife  
and children but leaving her a her proper proportion as she  
a the time of age or in excess very comfortable living  
at any time which she may desire of the greatest and  
uppon my death before Moore my Executor with full power  
to manage my estate as he may think proper

Codicil There is due me the sum demanded and  
there remaineth nothing in trust before my named which  
it is my will for making my day late against their to collect

in the care of the money remaining from the value of my  
lands then mentioned in the first state of my will
