and Testament in manner & form following (Wit) Agide I give all my
daughter Sally Dyer in consideration of her having done my best debt due
and received the inheritance of her son William Dyer my youngest
child I have to her his heirs & assigns.

I give & bequeath unto my son William Dyer, John Dyer & Samuel Dyer
and my daughter Sally Dyer and my grand daughter Eliza
I have each an equal share of all the residue of my property
both personal real & personal of which I may die in possession to them their
heirs & assigns.

I do hereby appoint my daughter Sally Dyer Executor for my son Samuel
Dyer to take care of him this Estate & out of which to support him

I do hereby appoint William Dyer my son of the State of Georgia
to be executor to this my last will & Testament in witness whereof I have
hereunto signed my hand & made and affixed my seal the Twenty first
day of May Eighteen hundred thirty five.

John Jordan's Will

In the name of God amen I John B Jordan of Northampton County
being weak in body but of sound mind & perfect memory
do make and declare this to be my last will & Testament in
the manner and form following (Wit) I

Item 1st I give and bequeath unto my beloved wife my Carriage & match of
horses also I leave her all the land North side of the Northampton
Rail Road with all the improvements thereon also I give a brown
& white

Item 2nd I give and bequeath unto William B Jordan & John B Jordan all
my lands lying South of the said Rail Road also the land I
purchased of Joseph B. & Roger, which I wish to be paid
for before any of my legates comes in for any part of the debts
of my perishable estate also my wish and desire is that I want
the lands of William B Jordan and John B Jordan to be sold
out of my youngest son Thomas Jordan to come
in for an equal share of rents with the other two sons until
the death of my wife or until William B Jordan arrives
to the age of twenty one year, my wish & desire is that all
the lands given a wage I may give that if either of them die be-
fore they come of lawful age my wish & desire is that my sons
should see it come from a mother to the last one.

Item 3rd I give and bequeath unto my youngest son Thomas Jordan all
of said lands after the death of my wife lying and being
on the north side of the said Rail Road.

Item 4th I give and bequeath unto my son William B Jordan a negro
boy by the name of Jack also unto my son John B Jordan a negro
boy by the name of Henry & I give unto my youngest son
Thomas Jordan a negro boy by the name of Richmond.

Item 5th I give and bequeath unto John Thomas Hannah son of my
daughter Eliza Branch a negro girl by the name of Martha.

Item 6th My will and desire is that all the balance of my negroes to
be equally divided between my wife and four children
namely Margaret Jordan, William B Jordan, John B Jordan
& Thomas Jordan.

Item 7th My wish and desire is that all of my perishable estate should
be sold & divided between all of my heirs with the exception of
Eliza Branch.

Item 8th I bequeath unto John B Jordan one Hundred Dollars.

Item 9th I nominate John B Jordan & James W Jordan my executors
to this my last will & Testament this 10th day of October Eighteen
hundred and thirty five.
