I Christopher Dudley of Guilford County State of North Carolina have
made & signed & published & do hereby make & sign & publish this
Instrument of writing my last will & testament trusting
that some time in the year of 1827 I gave to my son Edwina
Dudley the plantation on which I reside & other lands, and
kind of my negroes to be shared by family on half of my
stock & the property a will more fully expressed by reference
to deed of gift made at the time which gifts I do hereby
renew & confirm agreeable to the true intent & meaning.
I do hereby give & bequeath to my grand children & to their heirs, &c.
the portion of my Estate except a pecuniary share
I reserve of. Consisting of Lands, negroes, Stocks, Chattels & Effects
of every kind. I have shown above the lands & some of the badly
disposed negroes, stocks, Chattels & other effects. I have decedentary
with my Executors to sell or divide in part or whole. The
income of any sale to be invested in stocks of the United States
or State Banks or some other valuable & productive funds for the
use & benefit of my grand children after death of, for which purpose
I do hereby authorize & empower my Executors to sell & dispose of
in part or the whole of the lands, badly disposed negroes, stocks
Chattels & other effects at public or private sale at such time
or such term as may think most beneficial for said Legatee
I have my negroes may be divided & distributed in families as far as
practicable. The hire of the negroes if the negroes & dividend of
stocks if any may be appropriated to the maintenance
& education of my grand children after said children invested
yearly in stocks or funds aforesaid for their benefit

I give & bequeath to my Executors for purposes hereafter
 named my negro man Esau of Beachab his wife Agnes
Reck & in two children Edgar & John the plantation of
 thirty five acres of William & Stocks of all kinds & the
 plantation of five thousand dollars in cash to be made out
 of my Estate the negro also mentioned August forever
 in my Executors to hold for of service of all persons abovesaid
 settle them in the plantation before in them for their support
 & maintenance the income of said plantation & all the crops
 they the crops are in said plantation & how many the income
 support themselves & contribute to the support of the above named
 negro wife to that they may I give said sum to be used to my
 Executors & further August forever in my Executors to provide for
 the Education of the boys Edgar & John (Wrote to them) said
 them to some good schoolmaster, school & board them in
 their training & when of age to procure of report their educa-
 tion in column & legal form. The interest of the five thousand
 dollars I give & bequeath will be appropriated to the Education of
 said boys Edgar & John during their minority & on coming of
 age the said sum of five thousand together with the
 plantation & its appurtenances or the proceeds of sale thereof &
 during my Executors will pass they are to said boys Edgar & John
 or either of them in such a part & at such time to
 enable them to commence business & live in comfort
 & respectably so as in may deem discreet proper —

I give & bequeath to my grand children Edward &
Christina all one negro by each in place of Esau given
