ITEM: I, give and bequeath to my beloved wife & two sons equally all my household and kitchen furniture tools and utensils of every discription of which am possessed and all of my hogs,

ITEM: I give to my son in law Isaac Littleton ten dollars to be paid him out of my stock of cattle.

ITEM: I give and bequeath to my wife & two sons one cow and calf, each to her chosen by my wife out of my stock and my will is that the remainder of my stocks of cattle be equally divided between my wife, two sons, my daughter Penelope and the heirs of daughter Sarah lawfully begotten of her body to be divided equally to share and share alike either by sale or mutual division by consent.

ITEM: I give to my wife any monies debts due of or property not otherwise given for the support and maintenance of herself and two sons for the year to come together with what provisions may be on hand.

I do hereby constitute and appoint my beloved wife, Ferely Melton, Executrix and my when at the age of eighteen years (if he thinks proper to qualify) Executor to this my last Will and Testament utterly revoking all other former Wills or deeds of gift by hereto fore made declaring this to be my Last Will.

FOURTHLY: I give and bequeath to my two sons, William & Frazier Morton a right of lands on New River Banks to them and their heirs forever. I lend to my beloved wife Solemi Morton during her life or widowhood the use of all my household goods and plantations tools with my cattle and riding horse and stock of every kind and at her deceased I leave all my personal estate to be equally divided amongst my children.

Lastly I nominate and appoint my brother Benjamin Morton Executor and my wife Solemi Morton Executrix to this my Last Will in testifying and confirming this and no other to be my Last Will and Testament as witness my hand the 29th day of June, 1801.

In the name of God Amen: I Tamer Marshburn of Onslow County, and State of North Carolina being of sound and perfect mind and memory, (Blessed be to God) Do this sixteenth day of December In the year of our Lord One Thousand Eight Hundred and Twenty Three make and publish this my Last Will and Testament in manner following that is to say.

ITEM: 1st, I give and bequeath to my beloved brother, Daniel Marshburn one negro girl by the name of Ritty also one negro boy by the name of David after my brother Daniel pays three hundred & eight dollars as I shall hereafter direct then the said negro be unto him his heirs and assigns forever.

ITEM 2nd: I give and bequeath unto my sister Elizabeth Shepard two dollars to be paid by my brother Daniels out of the three hundred and eight dollars.

ITEM 3th: I give and bequeath, unto my sister Sarah Marshburn two dollars to be paid as the above.

ITEM 4th: I give unto my brother David Marshburn two dollars which is to be paid as in item the second.

ITEM 5th: I give unto my brother in law Hardy Files two dollars to be paid as you will see in item the second.

ITEM 6th: I give and bequeath unto my cousin Tamer Files daughter of Hardy Files two Hundred dollars to be paid her when she comes of age and in case the said Tamer dies before she comes of age then and in that case to be equally divided between all of my brothers and sisters to them their heirs and assigns forever.

ITEM 7th: I give unto my cousin Tamer Files daughter as aforesaid one cow and calf to her her heirs and assigns forever.

ITEM 8th: I give and bequeath unto my cousin Elizabeth Files daughter of Jesse Files one hundred dollars to be paid her when she comes of age out of the three hundred dollars and if she dies before she come of age, then to be equally divided between her sisters and brothers.

ITEM 9th: I give to Ritty Files my cousin daughter of Jesse Files one heifer to her her heirs and assigns forever.

To have and to hold upon this special trust and confidence never the less and to and for the several use and trust hereinafter mentioned that is to say to and for the use of the said "athanial Loomis during the term of her natural life and to and for the use of the heirs of her body or such person or persons as the said Clarrissa shall by her last will and testamnet or by any writing purporting to be her last Will and signed by the proper hand and name of the said Clarrissa declare and appoint and to and for no other use or uses whatever. IN the name of God Amen: I Benjamin Melton of Onslow County State of North Carolina, being weak in in body but of sound mind and memory calling to mind that it is appointed once to die do make and ordain this my last Will and testament in the manner and form following: I commit my Soul unto the hands of God that gave it hoping through merit and mediation of my blessed Saviour to receive free pardon for all my sins and my body committed to the earth from which it was taken and as to such worldly estate as it has pleased God to indow me with to dispose of in the following manner to wit: First my will and desire is that all my just debts be puntally paid.

2nd: I give and bequeath unto my two sons Thomas Melton and Andrew Melton Seventy Five acres of land whereon I now live If one of them should die under age or without lawful begotten heirs for the other to have his land to them heirs

ITEM: I give and bequeath unto my son Andrew Melton one cow or earlin a basin and two plates one iron pot to him his heirs and assigns forever. If either of my three children should die under age or without lawful begotten heirs for the other or others to heir their estates.

ITEM: I give and bequeath unto my wife Mary Melton all the remainder of my estate in doors and out to raise her children or give sell and dispose of among her children as she pleases or to sell to any other person as she sees proper.

Lastly I constitute and appoint my well beloved wife Mary Melton my sole and sole Executrix to this my last Will and Testamenet revoking all former Wills by me made satifying and confirming this and no other to be my last Will and Testament. ITEM: I give and bequeath, to my daughter Mary Marshburn my negroe girl named Dines, two cows and calves, one chest formerly called her chest to hef her heirs and assigns forever.

ITEM: I give and bequeath to my daughter Nancy Marshburn my negro wench Cheich, one feather bed and furniture two cows and calves, to her heirs and assigns forever.

ITEM: I give and bequeath, to my son Daniel Marshburn after my wife death or widowhood all my lands and plantations whereon I now live and my turners tools to him his heirs and assigns forever.

ITEM: I give and bequeath to my daughter Reba Marshburn one garl named Ede and feather bed and furniture one cow and calfe to her heirs or assigns forever.

ITEM: I give and bequeath to my son Henry Marshburn all my lands lying on Black Creek, and my negro boy named George and all my Cuppers tools to him his heirs and assigns forever.

ITEM: I give and bequeath daughter Elizabeth Marshburn my negro garl named Water one feather bed and furniture. and cow to her heirs and assigns forever.

ITEM: I give and bequeath Sary Marshburn my negrö garl named Dillice and one feather bed and furniture one cow and calfe to her and her heirs or assigns forever.

ITEM: My will and desire is after my wife's death or widowhood is for all my house hold and kitchen furniture to be equally divided among all of my daughters to them their heirs and assigns forever.
