

Know all men by these presents that I Robert Abercrombie of Orange County State of North Carolina am truly and firmly bound to Charles Abercrombie of the County and State aforesaid in the personal sum of Three thousand pounds specie to which payment will and truly to be made and done. I bind myself my heirs Executors & assigns by these presents sealed with my Seal & dated the fifth day of February 1788

The Condition of the above obligation is such that whereas the above bound Robert Abercrombie has received a Mortgage deed for fourteen hundred & twenty four and a half acres of Land from the late mentioned Charles Abercrombie without making any satisfaction for the same, but purely for the purpose of having it in his power to sell and convey the said for the said Charles Abercrombie, in the said Charles absence, as he is about to go to the State of Georgia & also out sums of money to collect from the said Charles both on Bonds and open Accounts to the sum of about Eleven hundred pounds specie.

Now in case the above said Robert Abercrombie his heirs Executors Administrators or assigns do return to the said Charles Abercrombie the said Land by way of Mortgage again or of said Land there being the pleasure the said Charles now lives on Ellabus Creek, and return upon fair settlement the monies arising from the above mentioned Bonds & open Accounts demanded by the said Charles his heirs Executors Administrators or assigns that then the above obligation to be void otherwise to remain in full force and virtue
