In the name of God Amen. I Thomas Capper of
the County of Orange State of North Carolina being
weak in Body but of perfect sense and Memory
(blessed be God for the same) do this 19th Day of
October in the Year of our Lord one thousand seven
hundred and Seventy seven I do hereby make and
publish this my last Will and Testament in manner
and form following. Viz. first I recommend my Soul
to Almighty God and my Body to the Earth to
be buried at the discretion of my Executors and Executors
hereafter named. Secondly I bequeath to my Dear
beloved Wife Anna Capper all my right Title claim
of all my Lands and moveables whatsoever with all
my Stocks of Cattle of all kind, excepting two
Cows and Calf already given to my Daughter Nancy

Capper. I also bequeath to dear Beloved Wife Anna Capper
Three Negroes Slaves named Marica Mary and Sam with all
and every thing before mentioned during her Widowhood and no
longer. I give and bequeath to my dear and only Daughter
Nancy Capper Two Negroes one named Lall the other named Mena
to her and Heirs forever. I also give and Bequeath to my
dear and only Daughter Nancy Capper, after my just and lawful
Debts are paid, and my Dear Wife Widowhood, all my right
and property and probate of all Lands Houses, Buildings Negro
Slaves, Goods and Chattels real and Personal wholly and solely and
for and Heirs forever. Lastly I nominate constitute and
appoint my Faithful and trusty Friends and Wife, Tapley
Cutter, John Capper and James Isaac Junior Executors &
Executrix of this my last Will and Testament hereby revoking
and disannulling all other Will or Wills by me made
in word or Writing. In Witness whereof I the said Thomas
Capper have to this my last Will and Testament set
my Hand and affixed my Seal the Day and Year above

the Testator as and for his last Will
