Know all Men by these presents that I James Frazer of Orange County & State of North Carolina for and in consideration of the sum of five hundred Guineas att Seventy one Shillings Sterling Money each to me in Hand paid by Thomas Hart of the County & State aforesaid the receipt whereof I do hereby acknowledge, have bargained sold & Delivered & by these Presents doth bargain sell & deliver unto the said Thomas Hart Twelve Negro Slaves to wit, John, Jim, Fanny, Charlotte, Tabby Aggy, Edie Jib, Eber, & George now in my possession and Estate & Colorado, run away, which said twelve Negro Slaves & every of them I do hereby warrant & defend unto the said Thomas Hart his Heirs & Assigns forever against the claim of all & every Person and Persons whomsoever.

Know all Men by these Presents that I Thomas Hart of the County of Orange and State of North Carolina for divers good cause and considerations me therunto moving have made ordained constituted and appointed and by these Presents do make ordain constitute and appoint my trusty Friends James Hogg and J. B. Banton of the County & State aforesaid my true & lawful Attorneys for me in my Name and to my use, to bargain sell or otherwise dispose of any part or parcel of my Estate either real or Personal to Collect the Debts that may be due to me and pay those that may be ~~due~~ due from me, hereby giving & by these presents granting to my said Attorneys James Hogg and J. B. Banton or either of them severally my sole and full power and Authority to make sign Seal and deliver for me and in my Name any Deed or Deeds Conveyance, or Conveyances to pass any Receipt or Receipts or to any other thing or things that they or either of them shall think necessary for the more effectually disposing of all and singular my Estate both real & Personal and settling adjusting & finally closing my Accounts in as ample and full a manner as I myself could do was I Personally Present hereby ratifying and confirming whatever
