

In the Name of God Amen I Andrew Harrison of Orange County in the Province of North Carolina being very Sick and weak in Body tho' of perfect mind and memory But falling to mind this Uncertainty of this transitory life do make and Ordain this my Last Will and Testament and do dispose of all my Estate in Manner & form following (to wit) I Give & Bequeath unto my well be loved wife Jam Harrison the use of Plantation where on I now live likewise the Land and Plantation on Moons Creek likewise a water Quist mill on the said Creek all which she is to have during her Natural life or widowhood with out any Interruption likewise I Give unto her One Negro woman Named Sarah and one namedabella & one Negro Man Named George and their future Increase during her life or widowhood & after her death or widowhood the said Negroes to be Equally divided among her of my Children (to wit) Milley Moore Elizabeth Harrison Minion Harrison Molly Harrison Jam Harrison & Andrew Harrison I Give unto my Son Nimion Harrison who is at Present of Unsound mind the Tract of Land on Moons Creek the Place always Intended for him after the death of his Mother provided he should recover his proper senses it is to extend down the said Creek to a marked line which is the dividing line between him & his Youngest Brother Andrew Harrison I Give him One Negro Boy named Bob & one Negro Girl named Phillis & their future Increase I Give him One Horse one Mare two cows & calves two Sows & Pigs to him and his heirs for Ever provided he should recover his proper senses

to as to be Capable of managing the Same but if he should never come to his proper Senses I Give that the Above mentioned Negroes and Stock after his death be Equally divided amongst my Children and it is my desire that my Son Nimion Harrison & his Estate be under the management of William Harrison & Thomas Harrison his two Brothers who is to Act as Trustees for him until he shall be Capable to Act for him Self I Give & Bequeath unto my Daughter Milley Moore & her heirs for Ever One Negro woman Named Sarah and one Girl Named Peggy — I Give & Bequeath unto my Daughter Elizabeth Harrison and her heirs for Ever one Negro Girl Named Anne & one named Esther I Give & Bequeath unto my daughter Molly Harrison and her heirs for Ever One Negro Girl Named Foe & one named Frank, I Give and Bequeath unto my Daughter Jam Harrison and her heirs for Ever one Negro Girl Named Rachel and one named Nancy I Give & Bequeath unto my Son Andrew Harrison and his heirs for Ever the Tract of Land where on I now dwell and water Quist mill on Moons Creek with all the vacant Land that I have Improved or Intended to be Improved adjoining the Mill after the death of his Mother or widowhood the Land & Plantation on Moons Creek which is Intended for my Son Nimion if he should die with out heirs to descend to my son Andrew & if he should die with out Lawfull heirs to be sold and the Money arising be Equally Divided amongst all my Children I Give & Bequeath unto my Son Andrew Harrison one Negro Boy named Little Bob also named Harry and one Negro Girl named Jeffy likewise one Silver Cane with my Name Engraved there on and if my Son Andrew should die with out a Lawfull heir I Give that

all his Part of my Estate above mentioned Should be Sold  
and the Money a Rising be Equally divided among the  
Rest of my Children—

I Item I give & Bequeath unto my Daughter Anna Ware and her  
heirs for Ever one Negro Girl Named Jobella  
Item it is my will & desire that that all the Rest of my  
Estate not herein Mentioned or disposed of may after my  
Just Debts be Paid be Equally Divided among all the  
Rest of my Children Willy Moon Elizabeth Harrison Matthy  
Harrison Nancy Harrison & Andrew Harrison to them and their  
heirs for Ever after their Mothers death

Item I give & Bequeath unto my two Sons William Harrison  
and Thomas Harrison five Shilling Each as they have already  
Received an Equal Part of my Estate

Item if any of my Children Should die with out Will it is  
my desire that the Estate of my Child or Children Shall  
be Equally divided among all the Rest of my Children

I Item I give unto Margaret Bayn One Cow & Calf

I do also Appoint William Harrison Thomas Harrison John  
Ware & William Moon my whole & Sole Executors of this my  
last will & Testament here in Revoking all and Discharging all  
Discharging all other wills by me formerly made in  
witness where of I have here unto set my hand and affixed  
my Seal this 16<sup>th</sup> day of May 1773

At the words to be read to my Son Andrew Harrison if he Should die  
without Lawfull Will Entailed before Signed

one feather Bed & Furniture to her and her heirs for Ever  
Item I give and Bequeath unto my Beloved Son Robert Burtin  
One Negro man Named James to him & his heirs for Ever  
also I give unto my Son Robert Burtin all the Remainder  
of my Estate of what kind soever to him & his heirs for  
Ever and I do now appoint my Beloved Son Robert Burtin  
my Executor to this my last will & Testament Revoking  
all other wills by me formerly Made in witness where of I  
have here unto set my hand & Seal this 22<sup>th</sup> day of May
