Memorandum of the last will and testament of
Sinnat Tate the Carpenters tools I leave to the discretion of my sons
of my son James the mill and vessels belonging to it to be jointly
in partnership between Samuel and George Tate the Serv^t known by
the name of George I give to my son George with a new Saddle and
Bridle and leave him under the Discretion of his Brother James
to school them and rent out his part of the plantation to pay for the expenses
until he becomes of full age I leave him a bed and furniture the gear
I leave to Daughter Margaret in order she should have one also
I leave to my Daughter Elizabeth the mare known by the name of
Neva and to Lillie the black mare I had of Andrew Mitchell
I leave Sinnat his bay Colt that is now two and one year I leave the
mother of the above Colt to Margaret the horse called Brian I leave
to my son George I leave my son James red horse and his halfe Colt
the one that he had before I leave to my Daughter before my

Callise gown I leave to Betty my black gown I leave to Agnes as
much as she chooses as the value of either of the above gowns - I
leave to my Daughter Sinnat to be put out at interest until she becomes
of age and to Margaret to be put out at interest for her use also and each of them
one Cow and half the Hubbard I leave to George the rest of the house
hold furniture I leave to the four younger Daughters to be Equally divided
between the four Daughters between Samuel and George the sum between
Samuel Nelson and me I leave between his own two Daughters
to be divided Equally between them and one Cow to his son David the
overplus I paid John Mitchell above his wife Tower I leave to his
Daughter Sinnat - I leave to Andrew Mitchell about one Cow and
half I leave to my Daughter Betty 1/2 - I desire and Request
Samuel Nelson to take Sinnat and Margaret under his care to
raise the I leave to my son James his Cow and after all debts and
charges is paid I leave my other Effects and money to my son George
and James oldest son if not a son to his oldest Daughter and I
nominate and appoint my son James Tate and Samuel Nelson
Executors of my Estate this Memorandum I have signed sealed
