I give to my son James that tract of Land at Deep River with all the increase that comes of a Negro woman names Jenny, he is not to enjoy any thing till he come of age. I give to my daughter Mary a Negro Girl names Keenah I give to my daughter Betty a Negro Girl names Sarah I give to my daughter Elizabeth a Negro Girl names Susan. I give to my son Daniel a plantation and the last Survey I made with part of the last Survey I made on, with part of another Survey I made, if my son Daniel has to them present or there after, or if he such he returns to James & James give to the said Daniel seven hundred young ones of Cattle & Swine.
