pounds lawful Money to me in hand paid by John Williams
of Chatham County attorney at Law at or before the sealing
and delivery of these presents the receipt whereof I do
humbly acknowledge and thence do humbly request release
and discharge the said John Williams his Executors
Administrators & C^o & Co^o bargained sold and delivered
by these presents I do hereby bargain sell and deliver unto
the said John Williams his Executors Administrators
aforesaid One Negroe Man Slave named Damon of the
age of twenty three years or thereabouts and all my
right property greatest therein To have and to
hold the said Slave and promises unto the said John
Williams his Executors Administrators & assigns to him to
and for her and their own proper use and as her of the
own proper Slave from hence forth forever more
and I the said John Homestead for myself my heirs
Executors and Administrators do hereby covenant
promise and agree to and with the said John Williams
his Executors & Administrators that he the said John
Homestead shall and will at all times hereafter warrant
and defend the said Slave to the said John Williams
his Executors Administrators & assigns against All
and that the said Slave is now sound healthy free
from fits and all disorders & sensible In witness
whereof I the said John Homestead have countersigned
and sealed this twenty sixth day of February in the
year of our Lord one thousand seven hundred and
ninety nine Sealed & Delivered John Homestead

but of sound and disposing mind and memory thanks
to God Almighty God and considering the uncertainty
of this transitory life do make this my last Will
and Testament in manner following hereby revoking
all other Wills by me heretofore made I do wit
Imprimis I give unto my beloved wife Elizabeth
the use and profits of my plantation Land bounded
as follow Beginning on my South line at a point due South
from the most westerly part of my cleared Ground
running thence North to Mr Lakes or T. Scotts old line
thence East to Armstrongs line thence South along Armstrongs
line to Bullous line thence west to the beginning including
all my houses & cleared land for and during the
Term of her natural life, chargeable nevertheless with
the payment of Five pounds Specia which I require
her to pay and satisfy unto my Son James his Heirs
and assigns forever
I give and bequeath to my said wife one choice Cow
my Old Horse Dick my Black Coll and all my Household
furniture (excepting the bed & furniture
called Rachels) to her, her Heirs and assigns forever
also give unto my said wife the use & services of my
Negroe Man named Tom during his natural life
I give and devise unto my Sons William and John
the remainder of my lands & Estate above mentioned
lying and adjoyning on the west end of said Land to be
equally divided by a North & South line between my said
