one Chest and trunk one side Saddle one half of
wearing apparel half Dozen Pewter plates and
give the other part of wearing apparel to my
Daughter Ephie Butler also give to my Daughter
Susannah Basswell five Shillings and I give to
son Alexander Bowling five Shillings, I also
to my son Andrew Bowling five Shillings, I also
give to my Son-in-law John Butler four Shil
I also give to my Daughter Elizabeth Bowling
five Shillings, I also give to my two sons abo
mentioned Archibald & Abraham Bowling

 defend the title of the said negro boy slave from
 the lawful claim or Claim of any person or persons
 unto the said John Davis his heirs Executors
 administrators or assigns forever In Witness whereof
 with the delivery of said Negro Boy Slave
 I have hereunto set my hand and affixed my Seal
 this 21th March 1784
