 her to be possessed & Enjoyed & I do hereby utterly
 revoke & disannul all & every other former
 & contrary Wills Legacies & bequests & Executors by me in
 any wise before named made & bequeathed Ratifying
 confirming this & no other to be my last will & Testament
 in witness whereof I have hereunto set my hand & seal
 the 25th day of March in the year of our Lord 1779
