 by the name of Nere, to have and to hold the said
 bargained Negroe unto him the said Abraham
 Thompson, his heirs and assigns forever, to the only
 use and behoof of the said Abraham Thompson
 his heirs and assigns forever, have bargained against
 the title & claims of all person or persons whatever
 In witness whereof I have hereunto set my hand
 and Seal this 24 day of August one thousand
 seven hundred and Ninety one

 of Maryland by his power of Attorney bearing Date the
 fourteenth day of September 1791 and authorise
 constitute and appoint Samuel Price of Washington
 County and State aforesaid his true and lawful
 Attorney to settle transact adjust perform & negotiate
 all his Affairs Accounts business and things whosoever
 of him the said Thomas Hart in the said State of
 North Carolina and also therein empower and
 Authorise the said Samuel Price at his departure
 or returning from the said State of North Carolina
 by writing under hand & Seal for that purpose
 to appoint Authorise empower such person as he
 should think fit to be and that as Attorney, for
 and in the room and stead of him the said Samuel
 Price, and with full power to transact all and
 convey the matters and things which the said Samuel
 Price was on the said Power of Attorney empowered
 to perform and execute.

Now know all men by these presents presents that the
 said Samuel Price hath made Ordained constituted
 Authorised and empowered Joseph Taylor Taylor
 of Granville County in the said State of North
 Carolina in the place and stead of him the said
 Samuel Price to do perform and execute all the
 business affairs and matters and things of him
 the said Thomas Hart in the State of North Carolina
 aforesaid in touching and concerning the estate of
 John Barton of Orange County in the said State of
 North Carolina deceased, and also enter & take

take possession of all or any of the property real and
 personal which is the said Joseph Taylor shall receive
 for and on behalf of the said Thomas Hart, of the
 Estate of the said John Barton deceased and to sell
 convey and dispose of the same agreeable to the
 Instructions or directions of the same under the
 hands of the said said Samuel Price and also
 or left with the said Joseph Taylor and bearing
 date the twenty sixth day October Seventeen
